Board Bylaw 9000 Board Powers & Responsibilities

The Governing Board of the Oakland Unified School District, commonly referred to as the Board of Education, exists under and derives its powers and duties from the Constitution of the United States, Constitution of the State of California, Charter of the City of Oakland, and acts of the Congress of the United States, California State Legislature, and the Oakland electorate.

Subject to the limitations of federal, state, and local law, the Governing Board of the Oakland Unified School District shall:

- Establish measurable Goals for Student Achievement.
- Establish a Theory-Of-Action, a coherent strategy for achieving its student achievement goals.
- Establish policies consistent with the Goals for Student Achievement and the Theory-Of-Action, and systematically monitor the implementation and effectiveness of such policies.
- Adopt a comprehensive and aligned district curriculum, and systematically monitor disaggregated student academic performance by grade and school.
- Adopt a fiscally responsible district budget, and systematically monitor the district's fiscal health.
- Advocate on behalf of students and public education at the local, state, and federal levels.
- Hire, support, and evaluate the Superintendent, General Counsel, and Board Executive Assistant.
- 8. Evaluate the Board of Education's own performance and effectiveness.

2013-2014 Board Strategic Objectives

- 1. Monitor the Superintendent's progress toward achieving his 2013-2014 Work Plan deliverables.
- Adopt a new OUSD Balanced Scorecard that establishes ambitious outcome improvement targets for all students, including specific targets to reduce outcome disparities among African American male students, English Learners, and Special Education students.
- 3. Develop and adopt new Board policies on Full-Service Community Schools, Effective Instruction, Student Assignment, and Results-Based Budgeting.
- 4. Ratify a new multi-year contract agreement with the Oakland Education Association.
- 5. Appoint a permanent Superintendent.
