### **ACTION REQUESTED**

Adoption by Board of Education of Resolution No. 1415-0176 - Appointment – Members – Intergovernmental Relations Committee.

### **BACKGROUND**

The President of the City Council, along with others, has expressed an interest in reestablishing the City-Schools Education Partnership Committee to work collaboratively, where City and District can, on issues for the benefit of the children of the City of Oakland.

I have recommended that the Board, as Legislative File 15-0312, approve reestablishment of the Intergovernmental Relations Committee. Assuming an affirmative vote on that Legislation, I also am nominating and recommending that the Board ratify appointment of the members named in Resolution 1415-0176 – James Harris, Chair, Jody London, Roseann Torres and Aimee Eng - as members of the Intergovernmental Relations Committee, effective immediately.

If approved, one of the first tasks of the Committee membership, will be to serve as the District's representatives on the joint City-Schools Education Partnership Committee. Councilmember, and former School Board member, Noel Gallo has been named the City's joint Co-chair of the Committee. It is anticipated that the joint Committee will hold its first meeting at 4 p.m., Monday, February 23, 2015 to begin its work.




