Subject 2023 Comprehensive Coordinated Early Intervening Services Plan (CCEIS) Amendment

Ask of the Board Approval by the Board of Education of Amendment No. 1 to the 2022 Comprehensive Coordinated Early Intervening Services (CCEIS) Plan due to an increase in funding.

Background The Oakland Unified School District is implementing an existing Comprehensive Coordinated Early Intervening Services (CCEIS) Plan. When OUSD received COVID resources, 15% of those funds were to be set aside for the CCEIS Plan. The original 2022 CCEIS Plan budget totalled \$1,353,434.00. The amended CCEIS Plan due to an increase reflected in the grant award notification (GANs) for resources 3010 and 3315 now totals \$1,450,090.05, an increase of \$96,656.05.

Discussion The 2023 CCEIS Plan is currently being implemented. There are no changes to the plan although Oakland USD received an increase to CCEIS Funding in the amount of \$96,656.05. The rationale is that the staff implementing the 2023 CCEIS Plan received an increase to their compensation, therefore the increased amount of CCEIS funding is absorbed by the increased cost to the staff implementing the plan.

Fiscal Impact

The LEA must reserve 15 percent of its 3010 and IDEA grant funds to address factors contributing to the significant disproportionality (See 34 CFR sections 300.646(c) and (d).) For Oakland Unified School District, the amount of funds that have been set-aside is now \$1,450,090.05.
