**ACTION REQUESTED**

Adoption by the Board of Education of Resolution No. 1415-0164 - Appointing, Members of the Measure G Parcel Tax Independent Citizens Oversight Committee.

**BACKGROUND/DISCUSSION**

The voters of the City of Oakland on February 5, 2008 enacted the "Oakland Unified School District 2008 Education Parcel Tax Measure "commonly known as "Measure G", the education special tax of \$195 per parcel, commencing July 1, 2009.

Measure G also included accountability provisions, among others, that an Independent Citizens Oversight Committee be established to "ensure that the proceeds ... are spent only for the purposes named in [the] measure.

The Board of Education, by Resolution No. 0809-0043, adopted August 27, 2008, and Board Bylaw (BB) 9131, Amended, on March 27, 2013, created the Measure G Parcel Tax Independent Citizens' Oversight Committee (hereinafter "Measure G Committee) and provided for selection and appointment of members thereof.

The Board of Education, on January 29, 2014, by adopted Resolution No. 1314-1024, reappointed members of the Measure G Committee of seven (7) members with staggered terms of two years and one year respectively, commencing, February 1, 2014.

The current term expires for three members of the Measure G Committee on January 31, 2015. Two of three incumbent members whose term expires on January 31, 2015, have are not seeking reappointment. The third member has served satisfactorily and has stated a willingness to continue to serve, if reappointed.

I, as President of the Board, pursuant to Board Bylaw 9131, hereby nominate each person named in the Resolve Clause of Resolution No. 1415-0164, attached, as a member of the Measure G Committee and recommend approval of said Resolution.

**WHEREAS**, the term of three members of the Committee expire on January 31, 2015; and

**WHEREAS**, each of the three incumbent members whose term expired on January 31, 2015, have served satisfactorily, is eligible for reappointment to an additional term and individually has stated a willingness to continue to serve, if reappointed,

**WHEREAS**, the President of the Board of Education, pursuant to Board Bylaw 9131, has nominated the incumbents named in the Resolve Clause below to continue to serve on the Measure G Committee,

**NOW, THEREFORE, BE IT RESOLVED**, the Board of Education, upon nomination by its President, hereby ratifies said reappointment of each person named herein as a member of the Measure G Committee, effective 12:01 A.M., February 1, 2015, for the represented category or expertise and term stated below:
