Action Requested

Adopt Resolution No. 1112-0265 - Authorizing the District to implement the Public Agency Retirement Services Supplemental Retirement Plan for certain CALSTRS and PERS Member District Employees.

Background

By Board Resolution No. 1112-0179, approved on March 14, 2012, the District entered into an agreement with Public Agency Retirement Services (PARS) to design a Supplementary Retirement Plan (SRP), for eligible certificated and classified non-management and management employees. The retirement plan would provide eligible participating certificated, classified and management employees with a monthly benefit of 75% of their final year salary, paid over a minimum of a five-year period. 13.79% of the eligible participants submitted a completed application packet to participate in SRP. This number includes 26 certificated non-management, 12 classified non-management, 5 certificated management, and 13 classified management employees. The cost to the District to implement SRP over a five year period is approximately \$558,000 per year for 5 years or a total of \$2.79 million. Assuming 100% replacement (not likely) of the retiring employees, over 5 year period the projected savings are \$1.008 million dollars.

Discussion

The Superintendent recommends to the Board that the District adopt the PARS Supplemental Retirement Plan, as part of the District Retirement Program, and authorize the District to implement the SRP Plan. If the Board authorizes implementation of the Plan, the following is the timeline:

- 1. Board action authorizing implementation of the Plan (May 9, 2012);
- Employees resign/retire from District employment (effective June 30, 2012); and
- 3. PARS benefits commence (August 1, 2012).

Recommendation

Adopt Resolution No. 1112-0265 - Authorizing the District to implement the Public Agency Retirement Services Supplemental Retirement Plan for certain CALSTRS and PERS Member District Employees.

Fiscal Impact

The cost to the District to implement the SRP over a five year period is approximately \$558,000 for five years or \$2.79 million.

RESOLUTION NO. 1112-0265

Authorizing the Oakland Unified School District to Implement the Public Agency Retirement Services Supplemental Retirement Plan for Certain CALSTRS and PERS District Employees

WHEREAS, as provided in Board of Education Resolution No. 1112-0179, approved by the Board on March 14, 2012, the District entered into an agreement with Public Agency Retirement Services (PARS) to design a Supplementary Retirement Plan (SRP), a retirement incentive that may encourage certain certificated and classified non-management and management employees to retire early; and

WHEREAS, the Supplementary Retirement Plan provides eligible, participating certificated, classified and management employees with a monthly benefit of 75% of their final year salary, paid over a minimum five-year period; and

WHEREAS, to be eligible for the program, the employee must be:

- 1) Employed by the District as of September 1, 2011;
- 2) Employed in a closing school
- 3) Employed in a high school
- 4) Employed in a SIG schools
- 5) All UAOS members (certificated and classified)
- 6) All Confidential Managers
- 7) Counselors employed in high schools
- 8) LCI TSAs who support high schools and have a credential to teach in high school
- 9) Home and hospital teachers who support high schools
- 10) For certificated employees, a minimum of 55 years of age with at least 5 years of District service as of the date the resolution is adopted
- 11) For classified employees, a minimum of 50 years of age with at least 5 years of District service as of the date the resolution is adopted; and

WHEREAS, the following is the implementation timeline for the retirement incentive program:

- 1) Board adopted resolution to approve Plan (March 14, 2012);
- 2) Enrollment packets mailed to eligible employees (Mid March 2012);
- 3) Employee orientation meetings (Late March, 2012);
- 4) Employee Workshops (Late April 2012);5) Enrollment window closed (April 30, 2012);
- 6) Board action authorizing implementation of the Plan (May 9, 2012);

- 7) Employees resign/retire from District employment on or before (effective June 30, 2012); and
- 8) PARS benefits commence (August 1, 2012); and

WHEREAS, 13.79 percent of the eligible participants submitted a completed application packet to participate in the SRP; and

WHEREAS, 26 certificated non-management, 12 classified non-management, 5 certificated management and 13 classified management employees submitted a complete application packet to participate in the SRP plan; and

WHEREAS, the cost to the District to fund the SRP retirement benefit over a five year period is approximately \$558,000 per year or a total of \$2.79 million dollars;

WHEREAS, assuming 100% replacement (not likely) of the retiring employees, over a 5 year period the projected savings are \$1.008 million dollars; and

WHEREAS, the District desires to adopt the Supplementary Retirement Plan and to fund the SRP Plan; and

NOW THEREFORE BE IT RESOLVED THAT, the Board of Education of the District hereby adopts the PARS Supplementary Retirement Plan, as part of the District Retirement Program, and authorizes the District to implement the 2011-12 SRP Plan.
