RE: Summary of Internal Affairs Complaints June-December 2013

From June to December of 2013, the Police Department conducted three (3) Internal Affairs Investigations. The following is a brief summary of the Internal Affairs Complaints investigated:

#### 1. OSPD IAD # 13-004

## Complainant:

Grandparent of Skyline H.S. Student

## Subject:

**OUSD Police Officer** 

## Background:

On June 18, 2013, received a complaint regarding a sexual assault incident that occurred on June 10<sup>th</sup>, 2013. An OUSPD Officer responded and conducted an investigation regarding a sexual assault of a student that attends Skyline H.S. The investigation included the interview of the student. The complainant felt her granddaughter signed a written statement without knowledge or an explanation of what was contained in the statement. The investigation revealed that there were several school officials present when the student gave her statement and the statement was obtained accurately.

The complaint against the Police Officer was **UNFOUNDED**. Since this incident officers have been provided with audio recording devices to assist in gather statements.

#### 2. OSPD IAD # 13-005

Oakland H.S. Parent

## Subject:

OUSD Police Officer

#### **Background:**

On July 1, 2013 the Police Department received a complaint regarding a fight that took place on May 20, 2013, at the Oakland High School campus. On that day OUSDPD Officers were called to the campus to investigate an assault. After an investigation was completed one of the combatants was arrested. The parent of the arrested student filed a complaint that her daughter was arrested and taken to juvenile hall. She also complained that the investigating officer did not provide her with their business card.

An investigation was conduct by the department and the complaint was **UNFOUNDED**.

#### 3. OSPD IAD # 13-006

## Complainant:

East Oakland Pride Parent

## Subject(s):

School Security Officer

## **Background:**

On September 23, 2013, the district received a complaint alleging that a SSO made an attempt to date a parent of a student and when the parent declined the SSO harassed her son by pulling him out of his classroom and sending him to the office, as well as denying him recess.

An investigation was conduct by the department and the School Security Officer was found NOT SUSTAINED for unprofessional conduct, and the allegations of retaliation against the student were UNFOUNDED.

An additional complaint was received by the District regarding searching of students at the Castlemont High School campus by the administration and school security officers. The Legal Department, High School Office, and the Police Department investigated this complaint. Based upon the investigation, additional training and on-gong training has been provided to the staff.

There is also one outstanding investigation from this reporting period that has not been completed as of yet. This investigation will be presented next reporting period.
