Chair Martinez introduced facilitator Milton. Milton introduced principle of the site, Dr. Denise Sadler of Sankofa and Principle Dennis of Kaiser Elementary, which are the two schools merging to this site. Both updated the room that they met to discuss potential of the school. 3 full sitze classrooms with extended space for kindergarten classes. "Strong bones". They did a walk through with key management. There are no evidence of leaks. The space and wood there are some strong opportunities with makeover. The infrastructure, plumbing and wiring is there. The school also has history and is connected to the community. The kindergarten classes can have a separate and safe space. Both are on board with this vision.

At each table there will be two structured questions, "What does this property mean to you and what concerns do you have?" "What ideas do you have for potential future use?" Some thoughts were:

Question 1:

- OUSD divesting themselves of any property prematurely.
- Two schools consolidating, will need more space.
- Not very welcoming, surprisingly not in worse shape.
- Question Board's pipe dreams for surplus property. (Use of property improves education and community overall)
- Walks by daily. "Eye sore", "Sad state", "Nuisance". Would be good if it is usable space, been here before with a similar exercise for this site with OUSD.
- Concerned that if it stays vacant and the board deems it surplus outside of education.
- Concerned as to why the Board decided to visit this site when consolidation is already in process.

Question 2:

- Educational space for Special Education

- *Special education- a space for self expression and tutoring*
- *Keep it as a Childhood Development Center*
- *Reading and Math support*
- *Resource space for Special Education, traditional classroom*
- *Pre-k or Socioemotional learning space for speech and IEP*
- *Thinking of history of Sankofa, kids with special needs should stay in larger student body*
- *Keep it a priority for education based activity in that space*
- *Teacher housing*
- *Wants to support plans of Sankofa*
