PLEASE TAKE NOTICE that the Governing Board (Board) of the Oakland Unified School District will hold a Public Hearing at 8:05 P.M., December 15, 2021 at its Regularly Scheduled Meeting for the purpose of presenting certain findings, taking public comment, and approving a Resolution adopting the findings and approving an Energy Services Contract with SunPower Corporation, for cost savings the District will realize by the development, construction and operation of an "energy conservation facility" in accordance with California Government Code Section 4217, et seq.

The "energy conservation facility" under consideration is the design and installation of battery storage systems and related improvements at Oakland High School. The Board's findings and the Energy Contract with SunPower Corporation shall require that the anticipated cost for electrical energy provided by the energy conservation facility will be less than the anticipated marginal cost of electrical purchases without the energy conservation facility.

The Public Hearing, as stated herein, will be held in the Great Room, LaEscuelita Education Center, 1050 2nd Avenue, Oakland, CA 94606-2291, via internet streaming via Zoom and/or Granicus Live Manager, simultaneously.
