Subject Resolution - Purchase of Cyber High Course Certifications - High School Network

Action Requested Approval of Board Resolution No. 1213-0134 - Authorizing the purchase of Cyber High course certifications for students enrolled in the Oakland Unified School District, for the period April 2, 2013 through June 30, 2014, in an amount not to exceed \$99,960.00.

Background and Discussion Cyber High is a supplemental electronic, standards-based state-approved program consisting of test and course certification to provide interventions for students in their efforts to become proficient in English Language Arts and Math and basic literacy skills. The program will provide students with additional academic support. The goal of Cyber High is to integrate educational curriculum and technology in using the power of the electronic medium to break down barriers imposed by classroom walls and provide students with experiences and resources not possible in the traditional educational setting.

Cyber High's curriculum has been used in many ways; from the traditional classroom setting to alternative educational settings. Cyber High has met the needs of many schools throughout the United States. The Cyber High curriculum is fully accredited through Fresno Unified School District, Roosevelt High School, and is aligned with California State Content Standards and Frameworks. Selected courses also meet the University of California's A-G requirements.

Cyber High offers all students new opportunities for achievement and productivity so that they can compete for the jobs of the twenty-first century in the information economy.

**Authorizing the Purchase of 8,330 Cyber High Course Certifications for Students
Enrolled in the Oakland Unified School District**

WHEREAS, Cyber High is a supplemental electronic, standards-based state-approved program consisting of tests and course certifications to provide interventions for students in their efforts to become proficient in English Language Arts and Math and basic literacy skills.

WHEREAS, the cyber High program will provide students with additional academic support;

WHEREAS, the Cyber High curriculum is aligned with the Content Standards and Frameworks of California and many of the Cyber High School courses meet the A-G requirements of the University of California and California State University Systems; and

WHEREAS, all Cyber High School is licensed, copyrighted, owned, and maintained by the California PASS Program of the Fresno County Office of Education; and

WHEREAS, from 2008-09 through 2012-13 school years, more than fifty two thousand (52,000) Cyber High exams were taken and since the 2008-09 school year, 6,459 District students have taken Cyber High courses;

WHEREAS, to continue to provide District students with access to Cyber High for the period April 2, 2013 through June 30, 2014, the District seeks authorization to purchase 8,330 Cyber High course certifications (the equivalent of 1,666 course units) in an amount not to exceed \$99,960.00;

NOW THEREFORE, BE IT RESOLVED, that the Governing Board of the Oakland Unified School District hereby authorizes and approves purchase of 8,330 Cyber High course certifications in an amount not to exceed \$99,960.00 using Title I funds.
