#### **Project Descriptions**

Madison Park Academy new high school classroom building - The new classroom building includes 14 classrooms, 2 labs, 6 offices, and 120 new parking spaces. This project supports the Board's designation of Madison Park Academy as a 6-12 program to support a full high school program to the existing middle school campus.

Glenview Elementary School new classroom building - A new modern classroom building has been completed replacing the old building. The new classroom building include: New accessible (ADA) ramps providing accessibilit, from street level to the main entry doorway, 21 classrooms, library, cafeteria, multipurpose room, stage and administrative offices.

Fremont High School - Construction - Increment 2: New 2-story Building - Completed August 2020

Construction - Increment 3: Building B Renovation - Estimated completion date November 2020.

Construction - Increment 4: Gymnasium, Football Stadium and Wellness Clinic - Estimated completion date December 2020.

The Central Kitchen - Current activity include continued training on kitchen equipment, installation of greenhouse, pizza oven, and additional fencing.
