BP 7000 Facilities

Concepts And Roles

The Governing Board recognizes that one of its major responsibilities is to provide healthful, safe and adequate facilities that enhance the instructional program. The Board shall endeavor to make the provision of adequate school facilities a priority in the district. Because the schools serve as a focal point for the community, the Board shall also strive to ensure that district facilities fit harmoniously and attractively into their neighborhoods and have flexibility of design to meet future educational and community needs.

The Board shall strive to have a school Ffacilities Mmaster Pplan in place and regularly reviewed in light of the district's educational goals. In accordance with this plan, the Board shall:

Approve additions or major alterations to existing buildings to meet the evoloving instructional needs of students.

The Superintendent or designee shall:

1. Assess the district's short- and long-term facility needs. This assessment will establish priorities for construction, renovation, and maintenance projects that:

a. Assign highest priority to the correction of unsafe conditions;

 b. Include maintenance costs as necessary to enable facilities to reach their intended life cycles;

c. Plan for and schedule preventive maintenance;

 Plan for and schedule system replacement when new schools open, schools are renovated or systems replaced;

e. <u>Disclose assumptions on which the plan is based, including growth</u> patterns and the financial and human impact individual projects will have on other parts of the organization.

f. Incorporate Board Policy 3511, Energy and Water Conservation.

g. Include a District-Wide Program on Sustainability and the design and construction of school facilities in accordance with the principles of the Collaborative for High Performance Schools (CHPS).
