## **RESOLUTION NO. 1213-0184**

Determining Preliminary Eligibility of Each Applicant for Provisional Appointment to the Governing Board District 4 Trustee Vacancy and Inviting Applicants, As Determined, To Public Session Interview With Governing Board

WHEREAS, Gary Yee, Trustee, Governing Board of the Oakland Unified School District (herein after "Board"), District 4, resigned his position as a Member of the Board, effective April 25, 2013, creating a vacancy; and

WHEREAS, the City of Oakland Charter otherwise specifies the qualifications, manner of election and terms of Board Members and provides in Section 404 of the Charter that "The provisions of the Education Code of the State of California shall apply as to matters not provided for in this [City of Oakland] Charter" and;

WHEREAS, the filling of a vacancy on the Board, not provided for in the City Charter, is a matter that applies under the Education Code, specifically Education Section 5091; and

WHEREAS, Education Code Section 5091 specifies that when a vacancy occurs on the Board of a school district, the Board thereof shall, within 60 days of the vacancy, either order an election or make a provisional appointment to fill the vacancy; and

WHEREAS, the Board on April 30, 2013, by Resolution No. 1213-0158, among other provisions, declared and determined that the District 4 Board Trustee Vacancy, for the term ending January 5, 2015, shall be filled by provisional appointment; invited application for the vacancy from eligible District 4 residents/voters to be filed through 5 p.m., May 17, 2013; and set the date of May 29, 2013 as the date for the Board in Public Session to review applications received and to select applicants, as determined, if any, for interview in Public Session on June 5, 2013; and,

**WHEREAS**, the Board received twelve (12) applications for the District 4 Trustee Vacancy by 5 p.m., May 17, 2013, one each from:
