**Subject** Approval of Individual Service Agreement Report for the Master Contracts between Non-Public Agencies and Non-Public Schools and Oakland Unified School District.

**Action Requested** Approval of Individual Service Agreement Report for the Master Contracts between Non-Public Agencies and Non-Public Schools and Oakland Unified School District for the purpose of providing special education and/or related services pursuant to an Individualized Education Plan ("IEP"), Individual Family Service Plan or Rehabilitation Act Section 504 Plan.

**Background** Federal Law and California Education Code require a Special Education Local Plan Area (SELPA) to provide a full continuum of program options. When a school district or SELPA does not have an appropriate public education program for a student, a non-public school (NPS) and/or the services of a non-public agency (NPA) shall be made available. The District places students in a NPS for services such as Day Treatment, Residential Treatment, Extreme Behaviors and Severely Disabled students. The District uses the services of an NPA to supplement in-house staff services such as Speech and Language Therapists. This Individual Service Agreement is necessary to meet the needs of a student requiring specialized care to meet his/her educational needs as deemed through his/her IEP.

**Discussion** Approval by the Board of Education of Individual Service Agreement Report between the District and Non-Public Agencies and Non-Public Schools for the latter to provide IEP related services for students on report pursuant to the terms and conditions specified in the Master Contract approved by the Board of Education on September 9, 2015 (File ID 15-1650).

**Recommendation** Approval of Individual Service Agreement Report for the Master Contracts between Non-Public Agencies and Non-Public Schools and Oakland Unified School District.
