Re: Transitional Kindergarten

Dear Drs. London and Smith:

Since Spring of this year, the Oakland Rotary Club – through its Youth and Education Committee (YEC) and the Oakland Rotary Endowment – and the Oakland Unified School District (OUSD) have been discussing opportunities by which the Club might support OUSD's Transitional Kindergarten (TK) classrooms.

By this letter, the Oakland Rotary Club seeks OUSD's approval of the Club's support of TK.

In pursuit of this collaboration, the Oakland Rotary Club proposes during the 2012-2013 academic year:

- (a) To "adopt" all eleven OUSD TK classrooms;
- (b) To present to OUSD a check in the amount of \$22,000, to be allocated to the TK schools at \$2,000 per classroom, to purchase developmentally appropriate materials selected by the TK teachers and their school principals;
- (c) To collaborate with the following "partners":

 - Bring a Book Foundation
 - Boys Scouts East Bay
 - City National Bank
 - Children's Fairyland
 - East Bay Community Foundation
 - Girls Inc. Alameda County
 - National Writing Project

 - Wells Fargo Bank



(d) To organize Rotary and other volunteers:

- (1) To assemble furniture, flower beds, and play structures
- (2) To host field trips (art & literacy at Children's Fairyland; art & biology at the Oakland Zoo)
- (3) To provide support to emergency preparedness classes for educators and guardians
- (4) To provide classroom assistance to teachers, particularly in the areas of math and science
- (6) To organize a toy drive
- (7) To evaluate Rotary's participation in the TK collaboration
- (8) To Support literacy by providing books and curricula and by reading to students.


