Staff Report Jennifer Lebarre, Director of Nutritional Services.

Ms. Lebarre gave a brief history of the School Lunch Program and reported on the Child Nutrition Act. The federally assisted meal program is operation at over 110,00 schools throughout the country providing nutritionally balanced, low cost or free meals daily to students 18 years old and younger. Reimbursement to districts is given based on the number free, reduced and paid meals served. To increase our funding of the program we must have a high participation rate. Families must complete a meal application annually to determine their eligibility for the year. The latest Child Nutrition Re authorization of 2004 added additional requirements for districts such as the wellness policy and a food safety program. Oakland has a budget of \$14.5 million budget for school meals spending \$6.6 million on food, salaries, indirect costs, supplies, etc. Lunch is served in all of our schools and two charter schools has contracted our services to provide lunches for them. Breakfast is served at 94 schools and afterschool snacks at 75 schools. 25,000 meals are served daily (breakfast, lunch, and afterschool snack). 52 schools have our salad bar program.

Changes in the cafeteria

- 1. In 2001 we removed sodas and candy sales in school cafeterias.
- 2. We are looking at the elimination of all high fructose corn syrup from our products and currently not allowing any new products in the schools containing high fructose corn syrup.
- 3. We are at zero trans fats according to USDA standards.
- 4. All fryers have been removed and we no longer fry any foods.
- 5. We serve 1% or non fat milk at schools.

Federal Stimulus Money

A grant proposal for \$1.3 million was submitted for school meal equipment for 64 cafeterias with notification expected by June 30th.

Child Nutrition Re-authorization Act

The program is reviewed every five years for changes and improvements. The District is asking for more money to purchase better food by increasing the meal reimbursement rate; elimination of the reduced price category; a change in eligibility and reimbursement

guidelines based on the cost of living of the state; more funding for equipment and facility upgrades; funds to train staff; extension of the cash in lieu of lunch program to the breakfast program; increased funding for the snack program; changes in Procurement's role; support of nutrition education in the classroom.

09-1836 SCA 6 - Voter Approval of Education Parcel Tax By 55%

Approval by the Board of Education, upon recommendation of Intergovernmental Relations Committee, of its support for enactment of State Constitutional Amendment (SCA) 6 (Simitian, D - Palo Alto), which if enacted by the voters, will permit imposition, extension, or increase of a parcel tax, as defined, by a school district, community college district, or county office of education upon the approval of 55% (a reduction from the present 2/3s requirement) of its voters voting on the tax.

<u>09-1837</u> Early Childhood Education - AB 1326 Pilot In San Mateo County (2003)

Scott Lucas, Aide to State Assemblyman Saundre' Swanson said there may be a legislative fix to address the amount of the money Districts sends back to the State every year. Currently the amount sent back is about 15% with this pilot program Mr. Lucas said he believes the District's amount can be reduced to about 2%. Assembly Bill 1326 turns over the responsibility for developing eligibility requirements and other rules to the local child care council in exchange for a mandated increase in the amount of students served in these programs. Documentation from San Mateo County and San Francisco County showing how these two counties raised their eligibility threshold from 75% to 85% of the state medium income was provided to the Committee. Mr. Lucas said he would like to see a draft proposal from the District by the end of the summer.

Lynne Rodezno said if the state medium income increases from 75% to 85% we will maintain more families in the Early Childhood Program.

President Gallo recommended our state legislator (with Mr. Lucas present) make a presentation at the June 10th Board of Education Meeting covering the Early Childhood Initiative, charter schools paying back the state loan, and any other pertinent state information that the District and the City should be aware of. At that time we would discuss the parcel tax. President Gallo said he would like a legislative presentation to become a part of the Regular Board Meeting.

Mr. Moran said she has been meeting with Council Member Jean Quan and said Council Member Quan thinks if we get the problem solving officers to know the schools and the principals on their beat, they will work with the principal on truancy in their area.
