RE: Santa Fe Elementary

Dear Dr. Smith:

Please take Santa Fe Elementary off the list of schools that will be closed.

The Oakland School District seems to think it is stretched to thin to operate very small schools or small schools not otherwise designed to be small.

I have a child that attends Santa Fe Elementary after five years of private school with small classrooms designed for individual attention to the child learning at their own pace. As a result of the smaller classes she finished Pre-K a full grade level ahead of herself.

The Oakland School District seeks to close Santa Fe Elementary because it wants to create a full service community district where every school offers high-quality instruction that provides quality programs with adequate services to meet student and family needs.

Santa Fe is a high quality school in a good neighborhood that has high standards and harnesses the resources to produce critical thinkers, rigorous competent academics, conditions that enable high levels of learning that prepare students for post-secondary success.

In November, 2011 there was a measure on the ballot known as and referred to as the Oakland School Achievement Support and Safety Measure. The measure states since 2004, student academic achievement in Oakland schools has improved faster than in any other large urban school district in the state, as measured by the Academic Performance Index Scores.

The District seeks to restructure schools to make them more competitive with other school districts and make compensation competitive with surrounding school districts to ensure that Oakland has the best prepared and most committed teachers and support staff. The measure also went on to say the District cannot provide the same level of school salaries the neighboring school district do and will lose up to 300 teachers annually to other school districts and professions. The school district wants to recommend closing schools despite Oakland schools have improved faster than any other large urban school district.

Learning takes place in all contexts and does not privilege one learning environment over another. Families and teachers are the primary influences on student success and should be supported. Taking Santa Fe off the list of schools that will be closed supports Santa Fe's high standards and rigorous competent academic conditions that enable high levels of learning that produce critical thinkers, competent readers, writers, speakers and reasoners.

Language and Arts Content Standards for California Public Schools states students should be able to compare and contrast plots, settings and characters presented by different authors, generate alternative endings to plots and identify the reason or reasons for and the impact of the alternative when reading. Santa Fe has a drama club which causes the students to compare and contrast plots, settings and characters presented by different authors and generate alternative endings to plots and identify the reason or reasons for the ending of plays which go along with the high levels of learning and skills acquired when reading in the classroom.

Santa Fe wants the District to build up the cultural and linguistic identity of the students and their families and will strengthen the base already rooted in child youth and human development in preparing for post-secondary success.

Santa Fe students learn social skills, problem solving, and conflict resolution along with strong accountability measures in a place with rigorous competent academics.

Santa Fe has just rebuilt its garden and has a chef which teaches its cooking class where students learn about nutrition along with how to prepare good foods.

Santa Fe wants the District to work in partnership with it with the belief that all students and families have the ability to succeed if provided with support.


President Obama believes standardized test are just one of the tools we use to make sure our children are learning. 'It just can't dominate the curriculum to an extent where we are pushing aside those things that will actually allow children to improve and accurately assess the quality of the teaching that is taking place in the classroom.' He will provide funds for states to implement a broader range of assessments that can evaluate higher-order skills, such as the skills the students at Santa Fe demonstrate with critical thinking and drama club. President Obama also states, 'students abilities to use technology, conduct research, engage in scientific investigation, solve problems, present and defend their ideas are one of the tools that we use to make sure our children are learning'. He states, 'we need to invest in our . . . schools and strengthen them not drain [them]/.

Presently, the second grade class is in discussion about having lunch with a scientist, where a scientist will come and talk to them while they eat lunch in the classroom.
