DISCUSSION

The District is currently determining appropriate classified staffing levels at school sites and central office departments for the 2012-2013 school year. Due to closing schools and restructuring of some school sites and departments, it is anticipated that reassignment of classified represented positions may be required. This will necessitate a hiring freeze to facilitate the placement of employees in current vacancies who may be impacted by bumping, position reductions and/or layoffs.
