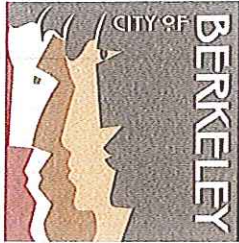

Jerome Wiggins

Jerome Wiggins of Berkeley is unique among those who work for the betterment of students and student-athletes. Unlike the overwhelming majority of those who serve on various North Coast Section boards and committees, Wiggins is not a professional educator, however he is as dedicated to serving youth as anyone who chose education as a career.

Wiggins, whose two sons graduated from Berkeley High School, is currently a transportation representative with the Federal Transit Authority in San Francisco. He was previously a planner/analyst with the Metropolitan Transportation Commission in Oakland and has served on the AC Transit board of directors.

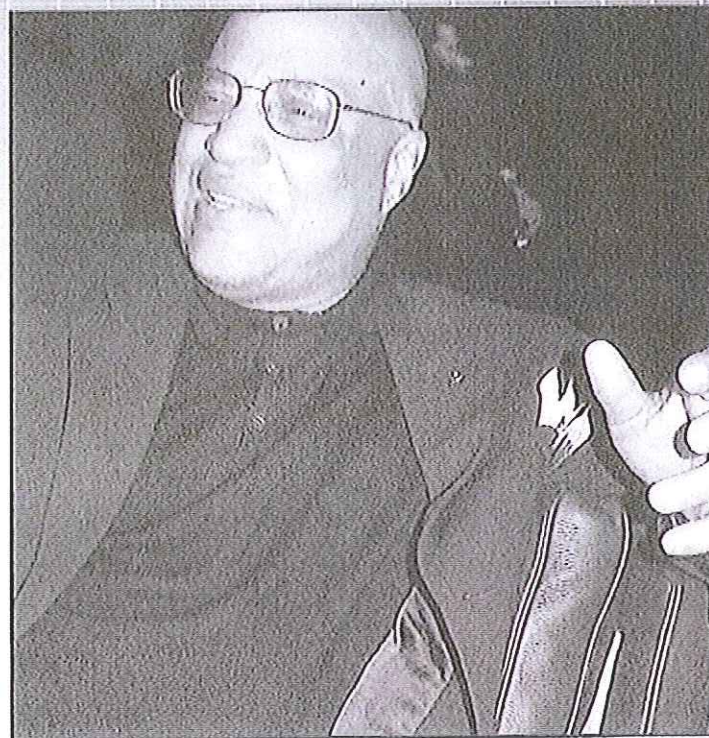
Still, his dedication to public education is unflagging. He was first elected to the Alameda County Board of Education in 1992. Twice he has been President of the county board, and in 1996 he was elected President of the California County Boards of Education while concurrently serving on the board of the California School Boards Association the same year.

He has been on the North Coast Section Board of Managers since 1994 and served as a NCS Executive Committee member from 2000 to 2009, including chairing the Eligibility Committee. Currently he serves on the Selection Committee for basketball and over the years has assisted on various seeding committees.

His dedication to education, even though it's not his chosen profession, and his body of work make him a worthy recipient of the North Coast Section's CIF Distinguished Service Award.

Wiggins is a professional administrator, but he is as hands-on as any high school coach. In 1998 he helped coach the Oakland Babe Ruth 15-year-olds to the World Series championship and the next season won the USABA Championship with the Oakland Oaks. He has also coached the Oakland Rattlers on an incredible road trip to Havana, Cuba, to play the Cuban Junior Olympic team. It took negotiations with the U.S. Treasury Department and the Cuban Ministry to make the trip happen.

Wiggins is a vigilant advocate for public



school funding and one of the mainstays of his philosophy is working to lower the student dropout rate. His family is a shining example of what the public education system can accomplish. Wiggins, who played football while earning his degree at Illinois, was a New York Urban Fellow, and earned his master's degree at UC Berkeley. His wife, Dorothy, is Vice Principal of Education at Alameda High. Their oldest son, Maceo, earned his master's degree at UC Berkeley and their youngest son, Grier, is an assistant baseball coach at Berkeley High.

Wiggins addresses his work with a strong sense of right, wrong and fairness. It is these values that have brought him continued support to represent the Alameda County School Boards Association as a member of the North Coast Section Board of Managers.

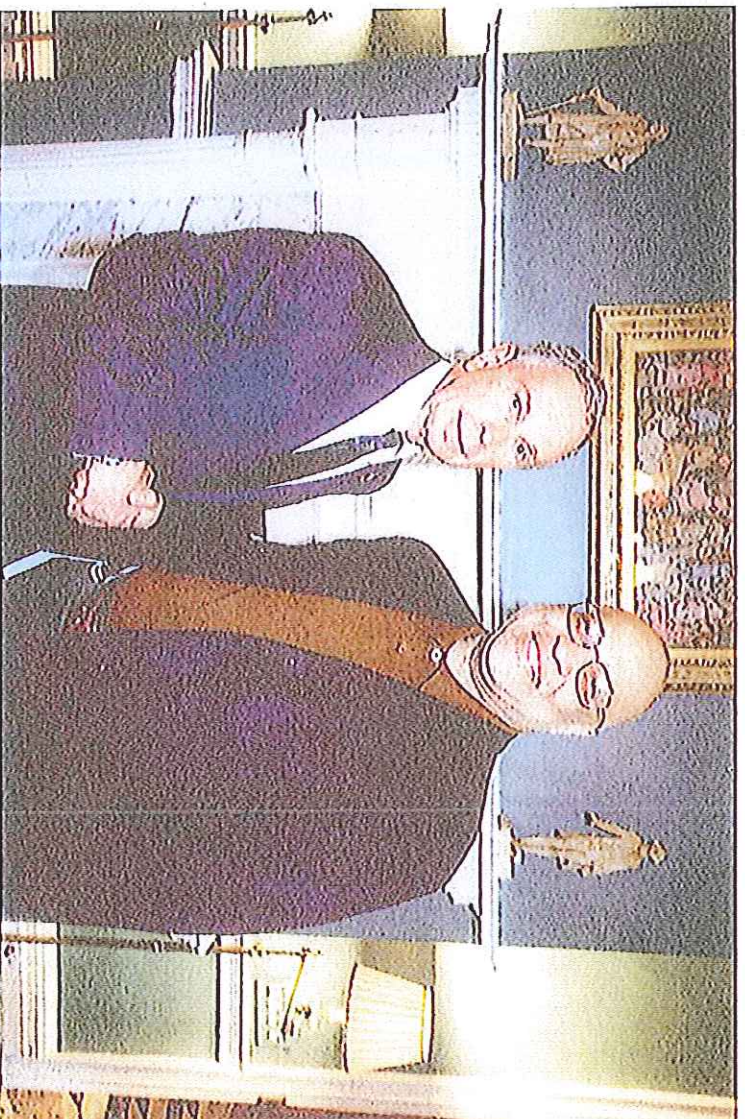
