Adoption by the Measures N and H Commission of a 2025-2026 Education Improvement Plan/Budget modification for Madison Park Academy to reduce \$15,556.25 Teacher Salaries Stipends by \$10,000.00 to \$5,556.25 and establish a new strategic action \$10,000.00 Professional Contracted Bus Services, as stated in the justification section of the New or Revised Strategic Action Section of the Budget Modification Form.
