ACTION REQUESTED

Ratification by the Board of Education of Acting President of Board’s reappointment of Reginald Mosley and Amber Childress, each having satisfactorily served for a term ending January 31, 2020, as a Member of the Measure G Parcel Tax Independent Citizens Oversight Committee, to a second and third term, respectively, ending January 31, 2022.

BACKGROUND/DISCUSSION

The duties of the Measure G Committee, as defined by Board Bylaw 9131, is to inform the public concerning the expenditure of parcel tax revenues and to review and report on the proper expenditure of taxpayers’ money generated by the 2009 Measure G parcel tax.

The Measure G Committee is composed of seven members, with staggered terms, appointed pursuant to membership criteria established by Board Bylaw 9131, with an individual's terms of appointment limited to a maximum of three two-year consecutive terms or the fulfillment of unexpired terms thereof.

Four-member terms expire on January 31, 2020 with two incumbents termed out. If reappointment of the two incumbents, recommended herein, are not immediately filled, the Committee will lack a quorum to function as of January 31, 2020. Meantime, open recruitment is underway to fill the two remaining openings as of January 31, 2020.
