

Dear Mr. Kakishiba and Dr Yee,

The Oakland Rotary Club through its Youth and Education Committee and the Oakland Rotary Endowment would like to continue their support of the transitional kindergarden (TK) program of OUSD with a project we call KinderPrep. As you know, last year we 'adopted' all 11 of the classrooms supplying money to the teachers, books, toys and two field trips to all of them. We also recruited a number of classroom volunteers. For 2013-2014 we have gathered resources to allow us to expand the program to all 21 classrooms and, based on a careful evaluation, make it more responsive to the needs of the students, teachers and the educational program.

By this letter, the Oakland Rotary Club (ORC) seeks the OUSD board's approval of our continued support. We propose the following:

- Provide cash support to each classroom teacher in the amount of \$2,000 for each new classroom and \$500 for each classroom we supported last year. This money will be provided to the "Oakland Unified School District" with the memo "Transitional Kindergarten/ LCI". The TK Unit will coordinate TK teacher's purchases and provide documentation to the ORC.
- Obtain a list of needed supplies from the teachers and purchase approximately \$6,400 at wholesale which will be distributed by Rotarian volunteers to each classroom.
- Provide free of charge at least one age appropriate field trip to each TK student, their teachers and chaperones including entrance fee, educational program and transportation.
- Using volunteers, purchase, pack and deliver to each classroom, on or about the Read Across America celebration of Dr Seuss' birthday, age appropriate books.

- 5. using volunteers, purchase, wrap and deliver to each TK student a holiday gift designed to reinforce classroom learning over the winter holiday.
- Expand the classroom volunteer program to provide at least one volunteer on a monthly basis to each classroom. Additionally, volunteers will be a major part of the field trips.
- 7. Seek collaboration with local corporations, non-profits and individuals to fund approximately 30% of the cost of these activities.
