Eric,

It was a pleasure to meet you on Friday. It is always nice to put a face with a name. After running the route from school to school in the pole car here is the findings:

The job can be done, however, there a number of problem areas. First I would ask that "no parking" signs be put up on one side of the street on Enos Avenue for the date of the moves. On High Street we are going to have to take the center of road in several areas and I don't see a way around taking down at least 3 phone lines because they are hung lower than legally required. If and when this happens the homeowner will need to be told to call 611 and the phone company will come repair the line at no charge at a higher level. This is unfortunate, but something that happens frequently in older communities - just something we have to deal with. We would have our lowest lowboy take both pieces of the American Modular building.

On International Blvd the loads will have to go down the center of both lanes most of the way due to new tree growth. Golf Links Road will have to have several places on the road closed to oncoming traffic so that the loads can get under trees and phone lines on the wrong side of the road.

Due to having to take the center of lanes and also the wrong side of the road in several places these loads will each require a pilot car from school to school. We will throw in a pole car at no additional expense over normal pilot car fees.
