Intent to Award

This memorandum is a formal notification of the intent to award California Apprenticeship Initiative New and Innovative Grant Program (CAI Program) funding by the **Chancellor's** Office Workforce and Economic Development Division.

The CAI Program grants awarded to selected California community colleges and K-12 local education agencies, collectively identified as Grantees in Table 1, are intended to create new and innovative apprenticeship opportunities in priority and emerging industry sectors or areas in which apprenticeship training is not fully established or does not exist. Grant award amounts are based on amounts requested in grant applications. Up to \$1,500,000 was allowed for Apprenticeship Program Implementation Grants, \$1,000,000 for Apprenticeship Program Expansion Grants, \$500,000 for Pre-Apprenticeship Implementation Grants, and \$120,000 for Planning Grants. These investments will support the state in achieving its goal to serve 500,000 apprentices between 2019 and 2029.

Grant Awards

Outlined in Table 1 are grant awards by grant type, region, college, primary occupation, funding status, and amount:

- "Funded" indicates applicants that scored at or above the minimum scoring threshold of 75 points and that were able to demonstrate Division of Apprenticeship Standards (DAS) program registration at the time of application.
- "Funded with Conditions" indicates applicants that met the minimum scoring threshold of 75 points but that were not able to demonstrate DAS program registration at the time of application or that did not demonstrate action to scale apprenticeship opportunities.
- "Not Funded" indicates applicants that did not meet the minimum scoring threshold of 75 points.

Appeals

Applicants have ten (10) business days from the day this memorandum is distributed and posted online to submit an appeal. If an appeal is submitted during this period, the grants affected will not be awarded until the appeal is resolved. The appeal must specify the grounds of appeal and must be based on the process and/or procedures used in the review and recommendation of application for awards.

Next Steps

Before the execution of grant award agreements, grant awards must be approved by the California Community Colleges Board of Governors (Board of Governors). Awards are anticipated to be submitted for approval by the Board of Governors during its May 2023 meeting date. Additionally, prior to execution of grant award agreements, Chancellor's Office staff will contact institutions that were not able to demonstrate DAS program registration to confirm registration status. Chancellor's Office staff may also contact any institution to request adjustments or modifications to the work plan and/or budget submitted as part of the grant application.
