Subject: **Measures N and H Recommendations for 2023-2024 Carryover Funds**  
Date: November 5, 2024

### OVERVIEW & OBJECTIVE

Sixteen OUSD district schools, ten charter schools, and the Measures N and H Administrative 10% **have unspent** Measures N and H funds from the 2023-2024 fiscal year. Of these 27 sites, 9 submitted their 2023-2024 Measures N and H Carryover Plans at the November 5, 2024 Measures N and H Commission meeting. These plans articulate the context that contributed to the carryover, **the amount and percentage of Measures N and H funds being carried over,** and a clear budget for the carryover funds.

Per Measures N and H Commission policy, approval from the Measures N and H Commission is required for all Carryover Plans. Measures N and H staff have reviewed the submitted 2023-2024 Measures N and H Carryover Plans and provided feedback to the school sites, which was addressed before submission to the Measures N and H Commission.

<p><b>Teacher Salaries Stipends: Extended Contracts to pay 3 teachers for working after hours to participate in the pathway team meetings, through June 30, 2025.</b> The Dewey Academy teacher team meets biweekly for 1 hour to work on pathway development and student support and intervention. This expenditure is aligned with our goals to increase shared practices and to develop integrated projects across content-area classes and English Language Development classes. In addition to those priorities, these meetings also include: after-school tutoring program and curriculum sharing. Budget: \$47.50 per hour x 11 hrs (1 hr/meeting) + 25% benefit costs = \$653.13 x 3 teachers = \$1,959.38 from Jan 2025 to June 2025. <p><b>Consultant Contract with the Oakland Public Ed Fund to facilitate and pay-out all of the Student Internship Stipends, December 13, 2024 through June 30, 2025.</b> OPEF will serve as the fiscal sponsor to process and pay-out all of the internship stipends as part of the Health Internships (e.g. Planting Justice, Medical Office Interns etc.). On average, students will be receiving \$500 stipends, for a total of 3 trimesters. In order for students to fully understand their own health. Students will learn the importance of quality nutrition, and healthy weight management practices for teens. Students will learn which foods are healthy and which foods are damaging. This is a year long program serving 120-160 students per year. Term, December 13, 2024 - May 27, 2025. <p><b>Licensing Agreements: funds to purchase Paxton/Patterson Level Up Renewal Package, 5-Year Subscription Licenses.</b>  This expenditure will support 70 students enrolled in the Pathway for the 2024 - 2025 school year. The licenses enable the teacher to engage in virtual events aimed at enhancing the educational landscape (The Educator Network) and offering supplementary learning opportunities across various modules such as Dentistry, Kinesiology, Health and Fitness, and EMT preparation. They facilitate collaboration among lab educators for idea exchange and joint problem-solving. This access provides both instructors and students with resources for college and career readiness. The subscription, which was valid for five years, has now expired. It is essential to maintain the validity of the licenses to ensure that both the teacher and students can utilize all available modules. OPEF will process ECCCO Stipends for student participants in Summer 2025. The ECCCO summer internship program provides students exposure to real-world work experience and college courses. This funding will provide stipends to 5-8 high school students participating in various summer internships approximately \$500 per stipend. Summer Internship and Peralta Institute stipends, through June 30, 2025. <b><i>OPEF can only invoice schools for student stipends with 100% participation and completion and the admin fees for those funds.
