Strengthen postsecondary advising support for CTMs: Because Street Academy does not have a full-time academic counselor and the Counselor-Teacher-Mentor model is such that the CTM is the primary academic advisor for Street Academy students, the OUSD Linked Learning Office Counseling Team can provide added support to CTMs as they carry much of the college and career advising work. Support from the counseling team to include tools and strategies for effective transcript review and resources aligned with effective tracking of A-G and graduation requirement progress.</p>	
<p>2. Provide supplemental pathway development support: High School Linked Learning will offer short-term Linked Learning pathway development support from consultant Robert Curtis to supplement support from the Alternative Education Pathway Coach.</p>
