#### ACTION REQUESTED

Approval by the State Administrator on behalf of the District of an agreement with Emery Unified School District for Oakland Adult Education to offer Adult Education classes within Emeryville's borders for the 2004-2006 academic years.

#### BACKGROUND AND PURPOSE

If a school district is unable to provide adult education services due to lack of facilities or an inability to secure teachers, it may contract with neighboring district to provide such services. (Education Code Sections 52511, 52530, 52572).

The Emery Unified School District does not currently have an adult education program and is jointly requesting with the Oakland Unified School District permission from the county superintendent of schools and the State Superintendent of Public Instruction for the Oakland Unified School District to provide adult education services within Emeryville district boundaries.

#### FISCAL IMPACT

Oakland Adult Education will generate ADA from two classes at Emeryville Senior Center. This revenue will cover all cost associated with offering these classes.

#### RECOMMENDATION

Approval by the State Administrator on behalf of the District of an agreement with Emery Unified School District for Oakland Adult Education to offer Adult Education classes within Emeryville's borders for the 2004-2006 academic years.
