Amethod Public Schools Mission Statement



*Our mission is to provide a **rigorous college preparatory education** and **character development** program that will **prepare students from underserved communities** to succeed in college and beyond.*

Proposal for Material Revision



Amethod proposes the **merger of Oakland Charter Academy and Downtown Charter Academy**. Amethod will formally **close OCA** and submits this material revision for DCA to accommodate this merger and closure.

What is proposed

- ★ Establish a **one-year** enrollment preference for **students displaced by the closure of Oakland Charter Academy**
- ★ Establish an ongoing number one priority enrollment preference for **unhoused students**
- ★ **Increase of 97 students** in DCA enrollment for 2026-27 to accommodate OCA students who wish to attend DCA

Rationale for Material Revision



Why this matters

- ★ Builds on a **stable and high performing program** at DCA to increase academic opportunity for OCA students
- ★ Increases the diversity of DCA, **better reflecting the diversity of Oakland**
- ★ Creates a more **sustainable financial model** and **increases resources** for facility improvements and student programming
- ★ Addresses the declining enrollment of students across the city by **closing a school**

Program improvements

- ❖ OCA students' access to **higher performing school option**
- ❖ Pooling resources for a stronger MTSS system that will serve a greater range and number of EL, SPED, and SED students
- ❖ Stable and effective leadership/staff
- ❖ Greater access to enrichment programming

Operational and financial improvements

- ❖ Strong **fiscal stability** and multi-year budget projections as a merged school
- ❖ Adequate **facility capacity** for all students with plans for internal and external improvements
- ❖ Smaller portfolio of schools enables greater support and resources from Home Office

Consolidating resources creates economies of scale, enabling expanded and higher-quality programming to meet the diverse needs of students
