Authorization for New General Obligation Bond Measure

Background

The Facilities Committee is recommending that the Board of Education determine whether to place a General Obligation Bond Measure on the June 2012 or November 2012 ballot to support continued modernization and seismic upgrades of District facilities. Prior to the meeting, we wanted to provide to the Board a matrix comparing traditional general obligation bonds (which require 66% voter approval) and Prop 39 bonds (which require 55% voter approval) and a timeline for the November 2012 elections.

Discussion

The Facilities Committee is recommending that the Board of Education determine (vote) whether to place a 55% (Proposition 39) or a 66% General Obligation Bond Measure on the June 2012 or November 2012 ballot to support continued modernization and seismic upgrades of District facilities and/or a separate facilities maintenance parcel tax measure for District facilities and, if affirmative, direct staff to take any and all necessary preparatory steps for such election(s).

	TRADITIONAL GENERAL OBLIGATION BOND	PROPOSITION 39
School Board Approval	Majority approval of the school board to place a measure on ballot.	Two-thirds approval of the school board to place a measure on ballot.
Ballot Measure	May contain all of the purposes authorized by law, or may be more limited. A specific school facilities project list is not required.	Must list the specific school facilities projects to be funded and such list must be certified by the school board after an evaluation of safety, class size reduction and information technology needs (list may include all schools).
Voter Approval	Two-thirds of the votes	55% of the votes
Election Dates	Generally on any Tuesday.	On the same day as a state wide primary, general or special election, or at a regularly scheduled local election. This generally means in June and November of even-numbered years. Any other date must coincide with a regular local election (e.g., a school board or city council election).
