Superintendent Smith talked about this being the work of a yearlong process designed around quality standards that exist in the District driven by community. This is one of the most powerful policy statements made by the Board and the commitment is to move the District to meet the high expectations described in the policy.

Director London wanted to know how this Policy will be rolled out. Director London wanted to know how a school would know they qualify for School Quality Development Innovation funds.

Superintendent Smith said the Board established the content work when it approved the Strategic Plan. There was a plan in place and this moves all those ideas into a policy.

The Innovation Fund – Many providers have said they would like to participate and create an Oakland City Fund to support both sustainable and durable transformation.

Superintendent Smith talked about the tremendous gains made by the District in the last four years, the structural deficit down to almost zero, increased the graduation rate and increased programming. He supports the Local Control Funding from the State.

Programmatic Side of the Budget - Deputy Superintendent Maria Santos
Deputy Superintendent Santos talked about prioritizing the Strategic Plan and the Board's
Strategic Priority so that every discussion is guided by the Priorities adopted by the Board.

A \$14 million reduction in the centralized budget that fund some of these programs.

Key areas that will require additional funding.

- Implementing the Common State Standards
- The implementation plan for the Voluntary Resolution Plan adopted by the Board
- Provide the resources and support to graduate higher numbers of students throughout the District

Kevin Taylor, Principal at McClymonds talked about the TSA Initiative that started August 8, 2012. He noted that having the extra time with the teachers has greatly impacted the school's ability to make changes in the curriculum as well as changes with the culture and climate on the campus.

Amy Carozza, Principal at Coliseum College Preparatory Academy (CCPA) talked about how high schools are pushing to develop students to be ready to meet the challenges of college and career. The Secondary Literacy Initiative at CCPS is a class for long-term English Language Learners. This class helps push forward the students academically that they are able to increase their SRI scores and moving students who previously did not make gains.

Fiscal Side of the Budget - Deputy Superintendent Vernon Hal Deputy Superintendent Hal talked about the revenues remaining flat.

- Anticipated contributions will increase by \$1.2 million with a net impact of resources available for expenditures that are reduced by \$3 million.
- Net expenses anticipated to increase by \$300,000 \$400,000. Expenses exceed available revenues by \$3 million. Included in the expenses are one-time items of about \$1.9 million.
- Today with the assumption of flat revenues, the District would have a structural deficit of \$1.2 million.
- Contributions will increase due to routine repair maintenance for Buildings & Grounds costs. In the current year some of it is being paid for out of one-time items
- Six million set aside for one-time employee compensation
- The Governor's budget anticipates a 1.6% cost of living increase for 2013/2014 equaling about \$3.8 million for the District. This additional revenue source allows the District pay 1.5% cost of living increase to employees totaling \$2.9 million applying the remaining \$900,000 to help reduce the structural deficit.
- The District anticipates receiving approximately \$9.3 million of additional funds if the

current Governor's proposed is passed.

**Board Member Comments** 

Vice President Hinton Hodge wanted to know which employees receive the cost of living increase.

Superintendent Smith said it was all bargaining units in the District.

Director Torres talked about her concerned that the District loses students at the high school level to charter schools.

Director Torres would like to see more detailed information on the improvements, the specific targets the District is trying to reach and more benchmarks that are broken down.

Deputy Santos said a more comprehensive high school report will be given to the Board in the High School Study Session which will break down all the data by types of schools and ethnicity to look at patterns over time. The targets addressed are those approved by the Board in the Balanced Scorecard.

Director Harris talked about the District's plan of increasing outreach to the Manhood Development Class and Family Engagement specific to Alliance Academy and Elmhurst Middle School.

Deputy Santos said the Manhood Expansion work of the African American Male Achievement (AAMA) is innovation work. She said those particular activities are funded by grants. She said the human and the fiscal capacity needs to be built to carry out the work.

Director London talked about California under investing in its students. She noted California contributes half of what other states are contributing. Director London wanted to know if proposals are coming from Deputy Santos that the District will not fund. Director London said she is interested in tracking elements of the Family Literacy Program and wanted to know if the elements that people find valuable will still be in the program. Deputy Santos said elements of the program are embedded in the Family Engagement strategy.

Vice President Hinton Hodge talked about the additional priorities that are necessary to continue the other investments made by the District. Vice President Hinton Hodge talked about the Voluntary Resolution Plan (VRP) and the African American Male Achievement (AAMA). Her concern was the AAMA work does not turn into the VRP work.

Deputy Santos said the District is looking at the VRP work around transforming school culture, investing in staff to be in strong relations with the students and to engage all community members in understanding restorative practices.

President Kakishiba talked about the eighteen priorities adopted by the Board which are the Balanced Scorecard objectives and would increases in the Balanced Scorecard will be achieved.

President Kakishiba wanted to know if expenses included \$3 million for the increased investments.

Deputy Superintendent Hal said "no".
