WHEREAS, Board of Education Bylaw 9100, adopted pursuant to Education Code Section 35143, prescribes that at the Annual Organizational Meeting of the Board of Education, the Board shall, among other responsibilities, organize itself annually for the conduct and exercise of its lawful responsibilities, including electing a president and vice president from its members, except student members; by said Bylaw designate its appointed officers; authorize signatures; develop a schedule of regular meetings of the year; develop a Board calendar for the year; designate Board representatives to other governmental agencies, community organizations and other entities; adopt goals and objectives for the year; and, at its option, may increase Board Member compensation within the limits of Education Code Section 35120; and

WHEREAS, pursuant to Board Bylaw 9130, the President of the Board is vested with the authority to establish and appoint members to standing committees, subject to advice and consent of the Board; and

WHEREAS, pursuant to Board Bylaw 9140, the Board is vested with the authority to appoint its representatives to other entities; and

WHEREAS, at its annual organizational meeting on January 4, 2010, the Board adopted, upon the recommendation of its President, Resolution No. 0910-0148, among other provisions, appointing in effect incumbents as of that date to membership on Board standing committees and as Board representatives to organizations for the 2010 term until such time as their successors are appointed,

NOW, THEREFORE, BE IT RESOLVED that the Board, pursuant to the fore stated Bylaws, confirms, each appointee to a standing committee as stated by the President in his Report at the January 13, 2010 Regular Meeting of the Board for the 2010 term, effective February 1, 2010, and/or until their successor is appointed, which are incorporated herein by reference and set forth in Attachment "A"; and

BE IT FURTHER RESOLVED that the Board confirms as the Board's official representatives to other entities, upon the recommendation of its President, each person so named by the President in his Report at the January 13, 2010 Regular Meeting of the Board for the 2010 term, effective February 1, 2010, and/or until their successor is appointed, which are incorporated herein by reference and set forth in Attachment "A."
