SUBJECT: Resolution Number 1112-0740 for Non-Public Schools and Non-Public Agencies Contracts for the 2012-2013 School Year

ACTION REQUESTED

Approval of Resolution Number 1112-0740 to allow the District to enter into and execute revised, amended, or new master contracts for Non-Public Schools and Non-Public Agencies for Special Education Programs for Fiscal Year 2011-2012 and to enter into and execute revised, amended or New Individual Service Agreements for Special Education students for Fiscal Year 2012-2013 in an amount not to exceed \$18,000,000.00.

BACKGROUND/DISCUSSION

Federal Law and California Education Code require a Special Education Local Plan Area (SELPA) to provide a full continuum of program options, to include Non-Public Schools (NPS). When a school district or SELPA does not have an appropriate public education program for a student, a non-public school and/or the services of a non-public agency shall be made available. The District places students in a NPS for services such as: Day Treatment, Residential Treatment, Extreme Behaviors and Severely Disabled students. The District utilizes non-public agency services to supplement in-house staff services such as speech and language therapy.

This Resolution Number 1112-0740 is necessary to meet the educational needs of students needing specialized care as deemed through their Individual Education Plan.

FISCAL IMPACT


The total cost for the Master Agreements and Individual Service Agreements for services to Special Education students utilizing Non-Public Schools and Non-Public Agencies, funded by Programs for Exceptional Children for Fiscal Year 2012-2013, is projected to not exceed \$18,000,000.00.

RECOMMENDATION

Approval of Resolution Number 1112-0740 to allow the District to enter into and execute Master Contracts and Individual Service Agreements for 2012-2013 Fiscal Year, in an amount not to exceed \$18,000,000.00.

WHEREAS, the service needs of Special Education Students necessitates greater programmatic and administrative flexibility to meet the Free and Appropriate Education needs of such students; and

WHEREAS, Non-Public Schools and Non-Public Agencies are certified by the State to provide specialized educational services in a setting for Special Education pupils that the District is not presently capable of providing “in-house;” and

NOW, THEREFORE, BE IT RESOLVED that the Governing Board approves a Master Agreement or Contract, subject to form and content approval by the General Counsel on behalf of the District, with each Non-Public School or Non-Public Agency listed in Attachments “A” and “B” respectively, and Individual Service Agreements in a total amount Not To Exceed \$18,000,000.00, for the fiscal year 2012-2013.
