Subj: Reappointment – Viola Gonzales - Measures B, J, and Y Independent Citizens' School Facilities Bond Oversight Committee

**ACTION REQUESTED**

Ratification by the Board of Education of President of Board's reappointment of Viola Gonzales (2<sup>nd</sup> Term), having rendered satisfactory service to date, to the Measures B, J, and Y Independent Citizens' School Facilities Bond Oversight Committee, for the term July 1, 2025, through June 30, 2027, respectively.

**BACKGROUND/DISCUSSION**

The duties of the Measures B, J, and Y Independent Citizens' School Facilities Bond Oversight Committee, as defined by the Measures B, J, and Y Approved Ballot Measure and Board Bylaw 9131, is "With respect to Measure B (2006), Measure J (2012), and Measure Y (2020), to provide advice and recommendation to the District regarding the expenditure of funds for bond related projects, to actively review and report on the proper expenditure of taxpayers' money for school construction and to take any necessary action in furtherance of its purpose including, but not limited to, receiving and reviewing copies of annual independent financial audits and deferred maintenance proposals, inspecting school facilities and grounds, receiving and reviewing cost-saving measures designed to reduce the costs of professional fees and site preparation. The Committee shall have the option to tour sites where Bond funds are being expended, with support from the Superintendent."

The Committee is composed of nine members, with staggered terms, appointed pursuant to membership criteria established by Board Bylaw 9131, with an individual's term of appointment limited to a maximum of three two-year consecutive terms or the fulfillment of said terms thereof.

Viola Gonzales has served on the G1 Commission since December 14, 2023, now satisfactorily completing the unexpired term, as of June 30, 2025, of an immediate predecessor.

## **RECOMMENDATION**

I, pursuant to Board Bylaw 9131, hereby reappoint Viola Gonzales, effective July 1, 2025, through June 30, 2027, to the Measures B, J, and Y Independent Citizens' School Facilities Bond Oversight Committee. I ask confirmation by the Board of the reappointment of Viola Gonzales.
