

## Regarding 2012-13 Compensation

The California School Employees Association Oakland Chapter 1 ("CSEA") and the Oakland Unified School District ("District") enter into this following Memorandum of Understanding relating to 2012-13 Compensation.

#### Agreement

- For the 2012-13 fiscal year only, the District shall provide a one-time lump sum payment to CSEA members of 2.35% of base salary.
- The one-time lump sum payment is separate from ongoing negotiations for a successor agreement, which negotiations shall continue.

## **Background (For Information Only)**

- The District and CSEA have a closed Collective Bargaining Agreement with term from July 1, 2010 through June 30, 2013 (the "Agreement").
- The District has set aside \$6 million of one-time funds for compensation to <u>all</u> employees and is in the process of negotiating a one-time payment with other employee groups for 2012-13.
- CSEA's portion of the \$6 million translates in to a one-time compensation increase of 2.35% of base salary.

### Dear President Kakishiba:

We have reviewed the Public Disclosure of Collective Bargaining Agreement for CSEA and Teamsters employees at Oakland USD covering the period beginning July 1, 2012 and ending June 30, 2013. The purpose of our review is to determine whether these agreements will have a material impact on the financial condition of the District in the current and subsequent two fiscal years.

It appears that the total cost of this settlement is approximately \$30K. The District used the 2012-13 Second Interim Report Multi-Year Projection to determine the affordability of the agreement. Following our review, it appears the District will indeed be able to maintain its required reserve for economic uncertainties for 2012-13 and the subsequent two fiscal years. Our recent review of the District's 2013-14 Adopted Budget also suggests that the cost of this settlement will continue to be affordable using the updated financial information.

Should any other tentative agreements be made, please submit new Public Disclosure documents to our office 10 days prior to the date the Governing Board will take action.
