Action Requested Approval of RESOLUTION TRANSFERRING NARCOTICS CANINE TO RESIGNING OSPD OFFICER GLORIA BELTRAN

Background The Sonoma County Sheriff's Department donated to Oakland Schools Police Department ("OSPD") a narcotics detection canine named "Lucy," which has been assigned to and trained by OSPD Officer Gloria Beltran. Officer Beltran has notified OUSD that she is resigning from OUSD. Due to Lucy's advanced age, the cost to retrain Lucy (if even possible) to continue to serve OSPD/OUSD with another police is prohibitively expensive. Officer Beltran wishes to accept Lucy as her own personal canine and has agreed to assume all responsibility for Lucy effective September 13, 2012.

TRANSFER OF NARCOTICS CANINE FROM OAKLAND UNIFIED SCHOOL DISTRICT TO RESIGNING OSPD OFFICER GLORIA BELTRAN

A. WHEREAS, the Sonoma County Sheriff's Department donated to Oakland Schools Police Department ("OSPD") a narcotics detection canine named "Lucy";

B. WHEREAS Lucy has been assigned to and trained by OSPD Officer Gloria Beltran ("Officer Beltran");

C. WHEREAS OSPD Officer Beltran has notified OUSD that she is resigning from OUSD;

D. WHEREAS Lucy is advanced in age, and the cost to retrain Lucy (if even possible) to continue to serve OSPD/OUSD with another police officer would be prohibitively expensive; and

E. WHEREAS Officer Beltran wishes to accept Lucy as her own personal canine;

F. WHEREAS, effective September 13, 2012, Officer Beltran has agreed to forever release and discharge the OUSD, and its Board of Education, the Superintendent, State Trustee/Administrator, agents, servants, employees, and agents from all actions, causes of action, damages, claims and demands, in law or in equity, of every kind and character, relating to Lucy or Lucy's future conduct.

NOW THEREFORE, BE IT RESOLVED that the Governing Board of the Oakland Unified School District authorizes transfer of the legal ownership and care of Lucy to Officer Beltran effective September 13, 2012.
