Subject Introduction of New Legislative Matter Resolution 2526-0107: Naming the Skyline High School Athletic Field the “John Beam/Tony Fardella ~~Sports~~ Field.”

Ask of the Board Adoption of Resolution No. 2526-0107 naming the athletic field at Skyline High School the “John Beam/Tony Fardella ~~Sports~~ Field” in recognition of the longstanding contributions of Coach John Beam and Tony Fardella to Skyline High School athletics, student development, and the broader Oakland community.

Background The District received a community-led request to formally name the Skyline High School athletic field in honor of Coach John Beam and Tony Fardella. Both individuals have made longstanding and meaningful contributions to Skyline High School athletics and student life through decades of leadership, mentorship, coaching, and support of student-athletes.

Consistent with Board Policy 7310 regarding the naming and renaming of District properties and facilities, the Superintendent directed staff to initiate the formal naming process. Staff convened a community advisory process that included outreach to Skyline High School stakeholders, alumni, students, staff, and community members.

As part of the process, the District distributed a community survey and conducted engagement efforts to gather broader input and feedback regarding the proposed naming recommendation. Survey responses demonstrated strong community support for honoring both John Beam and Tony Fardella through the naming of the athletic field.

The Facilities Committee and Board of Education have previously emphasized the importance of recognizing individuals whose leadership and service have had a lasting impact on Oakland students and school communities. This proposed naming aligns with those values and reflects Skyline High School’s strong tradition of athletics, mentorship, school pride, and student achievement

Discussion

Staff is recommending naming the Skyline High School athletic field the “John Beam Tony Fardella ~~Sports~~ Field.” The recommendation reflects the advisory committee’s input and the strong support expressed through community engagement.

Throughout the process, staff also explored the possibility of separately recognizing the stadium and field in honor of each individual. From a facilities and athletics practice standpoint, fields and stadiums are typically named after a single individual, allowing each honoree to receive a more focused and distinct recognition. However, after receiving committee and community feedback, staff is advancing the combined naming recommendation to honor both individuals together through the current field naming effort.

Additionally, should the District pursue and approve a future stadium project at Skyline High School, staff recommends that the District consider naming the future stadium the “John Beam Stadium” and the field the “Tony Fardella Field.” Staff also recommends that the District explore opportunities for a permanent monument or recognition feature celebrating Skyline High School’s longstanding athletics and sports legacy.

The proposed naming effort is also being coordinated alongside the District’s active Skyline field replacement project, currently underway through the Facilities Planning & Management Department

Fiscal Impact

The fiscal impact associated with the naming effort is anticipated to be minimal and will include signage, installation, and related recognition materials. Costs may be supported through existing Facilities project resources, operational resources, and community donations.

Implementation will be coordinated, to the extent feasible, with the District’s approximately \$1.5 million Skyline Athletic Field lighting replacement project and related athletic facility improvements to align work at the site and reduce duplication of effort.

project, the Board expresses its intent that the overall stadium be named the “John Beam Memorial Stadium” or “John Beam Stadium”, in recognition of Coach John Beam’s extraordinary legacy of leadership, mentorship, and lasting impact on generations of Oakland scholars, student-athletes, families, and the broader community; and

BE IT FURTHER RESOLVED that the Superintendent is authorized to take all actions necessary to implement this Resolution, including installation of signage and related recognition materials; and

BE IT FURTHER RESOLVED, that, as part of any future sports facility improvements and subject to available funding, the District shall explore additional opportunities to acknowledge and celebrate other Skyline High School athletes, teams, coaches, and sports programs whose achievements and contributions have shaped the school’s athletic legacy, including through plaques, displays, monuments, signage, or other appropriate recognition features.

Ask of the Board Adoption of Resolution No. 2526-0107 naming the athletic field at Skyline High School the “John Beam/Tony Fardella Sports Field” in recognition of the longstanding contributions of Coach John Beam and Tony Fardella to Skyline High School athletics, student development, and the broader Oakland community.

Background The District received a community-led request to formally name the Skyline High School athletic field in honor of Coach John Beam and Tony Fardella. Both individuals have made longstanding and meaningful contributions to Skyline High School athletics and student life through decades of leadership, mentorship, coaching, and support of student-athletes.

Consistent with Board Policy 7310 regarding the naming and renaming of District properties and facilities, the Superintendent directed staff to initiate the formal naming process. Staff convened a community advisory process that included outreach to Skyline High School stakeholders, alumni, students, staff, and community members.

As part of the process, the District distributed a community survey and conducted engagement efforts to gather broader input and feedback regarding the proposed naming recommendation. Survey responses demonstrated strong community support for honoring both John Beam and Tony Fardella through the naming of the athletic field.

BE IT FURTHER RESOLVED, that, as part of any future sports facility improvements and subject to available funding, the District shall explore additional opportunities to acknowledge and celebrate other Skyline High School athletes, teams, coaches, and sports programs whose achievements and contributions have shaped the school’s athletic legacy, including through plaques, displays, monuments, signage, or other appropriate recognition features.
