SUBJECT: School Portfolio Management Attendance Area Boundary Modification for Crocker Highlands Elementary and Glenview Elementary Schools

ACTION REQUESTED

Approval by the Board of Education of Resolution No. 1112-0187 - Amendment of Board Policy - Students - BP 5116 - School Attendance Boundaries - Cocker Highlands Elementary School and Glenview Elementary School Attendance Areas Effective July 1, 2012, modifying the Crocker Highlands Elementary and Glenview Elementary school attendance boundaries to reflect the map and list of affected addresses included herein.

DISCUSSION

On January 11, 2012, the Board of Education approved school attendance boundary changes as a result of the school restructuring decision made by the Board of Education on October 26, 2011. Included in those approved changes was the Crocker Highlands Elementary attendance area. Subsequent analysis by staff following the January 11, 2012 has determined that Trestle Glen Road, which traverses the interior of the Crocker Highlands Elementary attendance area, currently hosts one block where only those addresses on one side (even numbers) is included in the Crocker Highlands Elementary attendance area. The remaining section of the block (odd numbers) of Trestle Glen Road resides in the Glen View attendance area.

The staff recommendation addresses this anomaly by adjusting the Crocker Highlands Elementary attendance area to include the odd-numbered addresses on Trestle Glen Road as reflected in the attached map and list of affected addresses. Staff has determined that the inclusion of the affected addresses is not likely to cause an undue burden on the enrollment demands of Crocker Highlands Elementary attendance area. Signatures have been received by the district from a majority of the residence affected agreeing with the proposed change.

The attached attendance area maps and list of affected addresses is incorporated as effective, July 1, 2012 and for enrollment purposes for the 2012-13 school year.

Resolution No. 1112-0187

Amendment of Board Policy – Students – BP 5116 – School Attendance Boundaries – Cocker Highlands Elementary School and Glenview Elementary School Attendance Areas

Effective July 1, 2012

WHEREAS, the Oakland Unified School District is creating a great public school system with high standards of teaching and learning for every student and high standards of service to our schools with a recommitment to our shared values of equity, achievement, and accountability; and

WHEREAS, a core strategy of Oakland Unified School District is the management of a portfolio of schools that will provide a diverse portfolio of high quality schools for students and families both within neighborhoods and district-wide; and

WHEREAS, the Board of Education on October 26, 2011 voted to close Lakeview Elementary School, Lazear Elementary School, Marshall Elementary School, Maxwell Park Elementary School, and Santa Fe Elementary School, effective June 30, 2012; and

WHEREAS, attendance area boundary changes are necessary to ensure that all residences in the attendance areas of those closing schools are provided an attendance area designation for enrollment purposes; and

WHEREAS, the Board of Education approved the adjustment of the Crocker Highlands Elementary attendance area effective January 11, 2012; and

WHEREAS, staff has conducted additional analysis and determined that a single block of addresses on Trestle Glen Road – maintains odd numbers located within the Glenview Elementary attendance area and even number addresses located in the Crocker Highlands Elementary attendance area, while both the odd and even number addresses of the remaining sections of Trestle Glen Road are contained entirely within the Crocker Highlands attendance area; and

WHEREAS, staff has determined that inclusion of the odd addresses (approx 35 residences) within the Crocker Highlands Elementary attendance area is not likely to cause an undue burden on the enrollment demands of Crocker Highlands Elementary; and

WHEREAS, staff has received signatures from the majority of the residences affected by the proposed change affirming their agreement with the proposed change contained herein;

NOW, THEREFORE, BE IT RESOLVED THAT, upon the recommendation of the Superintendent of Schools, the Board hereby Amends Board Policy - Students - BP 5116 - School Attendance Boundaries, effective July 1, 2012, changing the attendance boundary of Crocker Highlands Elementary School to include the approximately 35 addresses listed in Attachment A, incorporated herein by reference as though fully set forth; and;

BE IT FURTHER RESOLVED that the Glenview Elementary Attendance Area, formerly the elementary school attendance area for the addresses listed in Attachment A, is hereby adjusted accordingly; and .

BE IT FURTHER RESOLVED that the Superintendent of Schools or his designee is authorized to take any and all action, save an action required of the Governing Board by law, regulation or Board Policy, to effectuate the foregoing.








Attendance boundary revised March 14, 2012
