ACTION REQUESTED

Approval by the Board of Education of Resolution No. 1819-0093A - Resignation of Date of Recognition of Oakland Unified School District’s 2019-2020 Teachers of the Year.

BACKGROUND

Annually the District identifies and honors its own, including one or more outstanding teachers as its “District Teacher of the Year” and to pay special tribute due to their tireless efforts, outstanding instructional skills and/or the achievements of their students. These honorees are able to go on to compete in the Alameda County Teacher of the Year Competition, and, if further selected, compete at the state and national levels, respectively.

The Board of Education, upon recommendation of Superintendent Kyla Johnson-Trammell and the Teacher of the Year Selection Team, on April 24, 2019, selected and designated Precious James, Tontra Love, and David Ramirez, individually, for exceptional service to the students of the District, as the District’s 2019-2020 “Teacher of the Year,” and designated the first Regular Meeting of the Board of Education in September, 2019, as its date of formal recognition of said teacher. Subsequently, it has been determined that all honorees cannot be present for the recognition scheduled for September 11, 2019. According, the Superintendent is requesting the Board to redesignate, its second Board Meeting in September as the date of recognition for said Teachers of the Year.
