Action Requested **Approval of RESOLUTION NO. 1314-0052, AUTHORIZING EXPENDITURE OF THE DISTRICT'S STATE ALLOCATION OF \$6.9 MILLION FOR THE IMPLEMENTATION OF CALIFORNIA COMMON CORE STANDARDS**

Background California Assembly Bill 86 ("AB 86"), allocated \$6.9 Million dollars to the District to support the integration of the common core academic content standards in instruction adopted in kindergarten and grades 1 to 12.

The monies are required to be used for the following purposes:

- Professional development for teachers, administrators, and paraprofessional educators or other classified employees involved in the direct instruction of pupils,
- Instructional materials, and
- Integration of these academic content standards through technology-based instruction, expenditures necessary to support the administration of computer-based assessments and provide high-speed, high-bandwidth internet connectivity.

The Board held the public hearing on November 6, 2013, on the District Staff's recommendation to use the Fund as follows: \$3.4 Million for curriculum materials and professional development; and \$3.5 Million for technology for instruction, learning and assessments.

Discussion The specific line item expenditures, totaling \$6,971,850 for the implementation



of California Common Core Standards are :

- \$1,800,000 for Classroom Libraries
- \$555,000 for Guided Reading Bookrooms
- \$344,850 for Elementary Professional Development
- \$250,000 for Secondary Professional Development
- \$522,000 for Stipends for English Language Arts (ELA), Math, and Instructional Technology Teacher Leaders
- \$3,500,000 for Chromebooks, carts, wireless access, and security

**AUTHORIZING EXPENDITURE OF THE DISTRICT'S STATE ALLOCATION OF \$6.9

WHEREAS, pursuant to California Assembly Bill 86 ("AB 86"), Section 85 (Chapter 48, Statutes of 2012) the Oakland Unified School District (the "District") was allocated \$6.9 Million dollars to support the integration of academic content standards in instruction adopted in kindergarten and grades 1 to 12, for purposes of establishing high quality instructions programs for all students in Oakland;

WHEREAS, pursuant to AB 86, the District is required to use the funds for the following purposes:

- Professional development for teachers, administrators, and paraprofessional educators or other classified employees involved in the direct instruction of pupils that is aligned to the academic content standards,
- Instructional materials aligned to the academic content standards, and
- Integration of these academic content standards through technology-based instruction for purposes of improving the academic performance of pupils, including, but not necessarily limited to, expenditures necessary to support the administration of computer-based assessments and provide high-speed, high-bandwidth Internet connectivity for the purpose of administration of computer-based assessments.

WHEREAS, on WEDNESDAY, November 6, 2013, at a Regular Meeting of the Board of Education ("Board") of the District, the Board held a public hearing on the District's State Budget Allocation of \$6.9 Million for the Implementation Of California Common Core Standards;

WHEREAS, at the public hearing, the Board heard public comment on the District Staff's recommendation to use the Fund as follows:

- \$3.4 Million for curriculum materials and professional development;
- \$3.5 Million for technology for instruction, learning and assessment

WHEREAS, more specifically, District Staff recommends the following expenditures, totaling \$6,971,850 for the Implementation Of California Common Core Standards:

- \$1,800,000 for Classroom Libraries
- \$555,000 for Guided Reading Bookrooms
- \$344,850 for Elementary Professional Development
- \$250,000 for Secondary Professional Development
- \$522,000 for Stipends for English Language Arts (ELA), Math, and Instructional Technology Teacher Leaders
- \$3,500,000 for Chromebooks, carts, wireless access, and security

NOW THEREFORE, BE IT RESOLVED THAT, the Board of Education of the Oakland Unified School District does hereby authorize the expenditures, totaling \$6,971,850 for the Implementation Of California Common Core Standards.
