

The Agreement, effective as of October 8, 2013, by and between the Oakland Unified School District ("OUSD"), and **Sue Piper ("Consultant")** is hereby further amended as follow:

Paragraph 2.1 is modified to change the term of the agreement through June 30, 2014.

Paragraph 2.2 is deleted and the following is substituted:

Consultant shall be available on call to the District and shall bill the District contract \$150 an hour, minimum of 2 hours. Consultant shall bill once a month. The total billing under this contract Amendment-II shall not exceed \$12,000.

This Amendment-II to the Agreement between the CONSULTANT and the District constitutes the entire understanding and agreement between the Parties.

All understandings, agreements, covenants, and representations express or implied, oral or written between the Parties are contained and merged herein. 




