Ask of the Board Approval by the Board of Education of Resolution No. 2324-0229, authorizing the

Alternative School of Choice Status for MetWest High School effective the 2024-

2025 school year and to request a new County-District-School (CDS) Code.

Background In May 2000, the Oakland Board of Education unanimously passed a New Small

Autonomous Schools (NSAS) District Policy calling for the creation of new, small, redesigned schools in Oakland's densely populated flatlands neighborhoods, home

to most of Oakland's low-income families.

Two years later, in 2002, MetWest High School opened as one of the first "new small autonomous schools" in Oakland and was designed to foster student success through experiential learning and an extensive internship program modeled after

the Big Picture Learning Model (BPL).

Among MetWest's most unique features is an academic program model that allows students to receive grade-appropriate and standards-aligned instruction from credentialed teachers three-days per week. Students spend the additional two instructional days at off-site internships of their choosing while receiving direct

support and mentorship from their Advisor.

The MetWest instructional model affords students unique learning opportunities where they receive an A-G aligned learning experience while simultaneously gaining real-life skills applicable in any post-secondary setting and in the workforce. Since its founding, MetWest's unique program has prepared students who have gone on to become scholars, community leaders, and entrepreneurs, many of whom have returned to serve OUSD as teachers and other key leadership staff.

Discussion

To provide its unique instructional model with three days of traditional in-person instruction and two days of off-campus internships, MetWest High School was intended to be established with the designation of an Alternative School of Choice (ASoC) by the California Department of Education. According to the <u>California Department of Education</u> (CDE), for a school to be classified as an alternative school of choice, it must meet at least the following criteria:

- The organizational entity must be within the state public education system.
- Students and teachers must be selected from among volunteers.
- The educational program must be essentially equivalent to grade-level programs of the district.
- The learning environment must be such that it allows students to achieve their maximum potential.
- Alternative schools of choice must also be offered in addition to, rather than in place of, the traditional program.

Though MetWest's instructional model has not changed since its founding, MetWest's <u>educational program type</u> is currently classified by the California Department of Education as "Traditional."

Per District staff review and the evidence provided, MetWest is not a "Traditional" high school. It should be reclassified as an "Alternative School of Choice," given it meets the criteria required by CDE.

Correcting MetWest's educational program type to accurately reflect its status as an Alternative School of Choice will give the community a true and accurate understanding of its unique program. ASoC status will also allow MetWest to accurately capture student attendance via the Independent Study attendance accounting model, given the school's instructional program includes in-person and off-campus learning via internships. Correcting the school type will also require a newly established County-District-School (CDS) Code since, per the CDE, existing CDS Codes cannot be repurposed when changing a school's designated program type.

WHEREAS, To most accurately reflect MetWest's unique instructional program model and to effectively capture student attendance data, it is most appropriate for MetWest High School to be classified by the California Department of Education as an Alternative School of Choice.

WHEREAS, MetWest is currently classified as a traditional high school according to the California Department of Education under County-District-School (CDS) Code 01-61259-0100701.

WHEREAS, Per the California Department of Education, a school's current County-District-School (CDS) code cannot be repurposed when changing a school's designated educational program type.

WHEREAS, A new CDS Code will need to be established for MetWest High School upon the change of the classification of the school's educational program type.

NOW, THEREFORE, BE IT RESOLVED, the Board of Education approves changing MetWest High School's program designation from "Traditional" to "Alternative School of Choice" per the criteria established by the California Department of Education.

BE IT FURTHER RESOLVED, the Board of Education approves the closure of MetWest High School's current CDS Code 01-61259-0100701.

BE IT FURTHER RESOLVED, the Board of Education approves the District's request to the California Department of Education to establish a new CDS Code for MetWest High School.
