**Action Requested** Public Hearing and Adoption by Board of Education of Resolution No. 1213-0195

into 2013-2014 District Budget.

**Background** Assembly Bill 189 amended Education Code Section 42605 and changed the public hearing  
requirement regarding the use of the Tier III funds. The original ABX4 2, Education Code  
Section, 42605, paragraph (c) (2) and (3) requires an annual public hearing on the proposed  
use of funds for the Tier III Categorical Programs. Now the public hearing must be held at  
a regularly scheduled board meeting prior to and independent of the meeting at which the  
annual budget will be adopted.

**Discussion** Present and discuss the acceptance of SB70 Categorical Tier III Flexibility Funds and  
present, discuss and approve the proposed use SB70 Categorical Tier III Flexibility Funds;  
the proposed use of funds is for any educational purpose in order to provide services to  
school districts and for student programs. District staff will be available to answer any  
questions concerning the acceptance of and use of the SB70 Categorical Tier III Flexibility  
Funds.

**SB70 Tier III Flexibility Acceptance and Uses of Funds**

**WHEREAS**, the enacted 2013/14 California State Budget and SB70, Chapter 7/2012, Statutes of 2009, authorizes school districts to use funding received from the State for Tier III programs, for any educational purpose, to the extent permitted by federal law, for seven years from 2008/09 through 2014/15 pursuant to Education Code 42605; and,

**WHEREAS**, the Superintendent of Schools is recommending that said funds be flexed, accepted and used to meet District education needs as outlined in the Resolve clause below in the amount of \$39,182,082,

**NOW, THEREFORE, BE IT RESOLVED**, upon recommendation of the Superintendent of Schools, the Board of Education hereby accepts and approves for District the use of SB70 Tier III funds as stated below, pursuant to the terms and conditions of the enacted legislation, and, hereby, concurrently incorporates and adopts said funds in the sum of \$39,182,082, into and as part of the adopted 2013-2014 District budget as stated below:


