Our Mission

Together we aim to improve local programs and policies to serve the unique needs of foster students, and to involve caregivers, families, staff, school board members, school administrators, and the public in supporting foster students.

We advocate as part of the process for the Local Control and Accountability Plan to ensure that decision makers understand the experiences of foster students and plan for their success.

We showcase the promise and brilliance of OUSD foster youth.

- 1. OUSD has the greatest number of foster youth of any district in Alameda County.**
- 2. About 40% of OUSD foster students have disabilities and need Special Education support. The majority are African American.**
- 3. About 30% are in elementary, 20% in middle, and 50% in high school.**
- 4. School sites rely on centralized services to support these highly mobile students across many contexts in the sustained and flexible ways that they need.**

We must all know and defend the rights of foster youth.

We, the members of the LCAP PARENT AND STUDENT ADVISORY COMMITTEE, represent the families in all of the schools and educational programs of OUSD.

As parents and students, we center those who are most affected by the decisions made in our district.

We uphold the leadership of families as we promote respect for our work within school site and district committees.

We rely on our connection to school committees so that we can reflect the experiences and priorities of school communities.

Parent members of PSAC are elected by parent members from the *School Site Councils* and *Site English Language Learner Subcommittees* of schools in our electoral districts.

Student members are elected by the student leaders of All City Council.

Elections for membership in PSAC are held in September. Members serve for a minimum of two years.

Up to seven members are elected to serve as Lead Delegates. They are the officers who steer the work of the committee.



28 parent/guardian members (4 from each electoral district) and 9 student advisors

LCAP PSAC Elections



Parent members of School Site Councils (SSCs) and Site English Language Learner Subcommittees (SELLS) will elect the parent representatives that will represent them on PSAC.

Schools must establish their SSCs and SELLS in time for these important districtwide elections. **If they have not done so, schools can send members of SSC and SELLS who are still at the school, especially continuing members.**

Vacancies for the September 18 PSAC Elections

District 1	4 vacancies (1 also serves on the District English Language Learners Subcommittee–DELLS)
District 2	2 vacancies (1 serves on DELLS)
District 3	2 vacancies (both serve on DELLS)

Some of our concerns about the establishment of school committees:

- 1) Deadlines for committees must support election into PSAC and DELLS.**
- 2) Due to the timing of budget development, PSAC and DELLS cannot afford to delay elections past September.**
- 3) OUSD is entering a school redesign year. All district committees must be ready to channel the voices and perspectives of families.**
- 4) Members of school committees should serve two-year terms so that there is some leadership continuity from year to year.**
- 4) OUSD policy about the establishment of ELL subcommittees (SELLS) is being violated. As a result, families of ELL students do not have avenues for real voice and representation.**
- 5) Authentic representation of ELL families requires that schools convene their SELLS first. This is not current practice.**
- 6) School representatives must clearly designate representatives to attend district committee meetings.**
