Gonzales stated the intent of the proposed legislation is to affirm or reaffirm that the additional Oversight Measures, applicable to current Bond Measures, adopted by the Board in June 2020, will carry over to the Measure Y GO Bond, and to also affirm it is the intent of the Board to assign Oversight Responsibility for Measure Y, if adopted by the voters November 2020, to the current Measures A, B, J Bond Oversight Committee.

The Item was also Amended, by mutual Agreement of the Committee Members, adding clause to delineate or clarify that the Legislation's intent, if adopted, while fully applicable to the Oversight Committee as a body, the current membership of the Oversight Committee is subject to the current term limits imposed by state law.

The Legislation, as Amended, was recommended favorably to the Board of Education, by the Committee, for consideration and possible adoption by Board at its September 23, 2020 Regular Meeting.
