AUTHORIZATION TO THE SUPERINTENDENT TO CREATE FULL TIME SSO MANAGER POSITION REPORTING TO THE DISTRICT CHIEF OF POLICE AND TO ELIMINATE THE .5 FTE SSO MANAGER POSITION

WHEREAS, it is the goal of the Oakland Unified School District to provide a safe, nurturing supportive environment where students can learn, excel and be prepared for college and career;

WHEREAS, School Security Officers ("SSO") are responsible for the overall safety and security of the school, play a critical role in the school's culture and climate, and provide the first line of defense to defuse and de-escalate tensions when they occur;

WHEREAS, a calm, structured, and positive learning environment is top priority for SSOs;

WHEREAS, the District employs approximately 90 SSOs, who are currently supervised by a .5 FTE (half-time) SSO Program Manager;

WHEREAS, in order to ensure organizational effectiveness, accountability, successful leadership and management of 90 SSOs, and provide a safe, nurturing environment for students, the Superintendent recommends that the SSO Manager position be a full time position;

WHEREAS, a full time SSO Manager position aligns to the District priority of safe and secure schools for all Oakland students:

WHEREAS, due to continuing budget shortfalls and lack of funds, the District is not able to maintain the .5 FTE SSO Manager position and a full time SSO Manager position;

WHEREAS, the Education Code requires action by the Board of Education if services for classified staff are in good faith to be reduced or eliminated in order to permit the layoff of classified employees due to lack of funds;

NOW THEREFORE, BE IT RESOLVED, that the Board of Education of the Oakland Unified School District does hereby authorize the Superintendent to create a full time SSO Manager position effective during the 2014-15 fiscal year;

BE IT FURTHER RESOLVED, that the Board hereby further authorizes the Superintendent to eliminate the .5 FTE SOO Manager position for lack of funds; and

BE IT FURTHER RESOLVED, that the Board hereby further authorizes the Superintendent or his designee to send appropriate 60-day notice to any classified employee whose position is impacted by the elimination of the .5 FTE SSO Manager position and to take all proper steps to eliminate said position.
