K. Adoption of the Committee General Consent Report

Director Spearman said she read the School Site Safety Reports on today's agenda and there were a lot of things missing in some of the plans. Director Spearman said there were compliance issues for the District citing some schools lacked confirmation of required monthly Fire Drills/Earthquake Drills and the principal's signature on the Safety Plan.

Chief Sarna said he worked with the REXOs and NEXOs offering drop in training for principals and no one showed up for the training. He said it is up to the school sites to submit the plans in a timely manner.

Director Gallo suggested sending the Safety Plans back to the school sites to be completed. He said there should be a staff person responsible for reviewing the plans and making sure the plans are complete. Once completed by the school sites, the plans will come back to the Safety Committee for approval.

Chairperson Spearman suggested Chief Sarna work with the General Counsel and the Superintendent to ensure the plans are completed and sent back to Chief Sarna.

Director Gallo made a motion and Chairperson Spearman seconded the motion to table the Consent Report so that Chief Sarna can return the plans to the school sites to be completed. Chief Sarna will bring the completed Safety Plans back to the next Safety Committee Meeting for approval.

General Counsel Jacqueline Minor suggested the Deputy Superintendent for Instruction, Maria Santos, come and explain to the Committee why the Safety Plans have not been done. General Counsel Minor recommended, along with Chief Sarna, Ms. Santos be made aware of your concerns and the Committee's expectations to see improvements in the plans. General Counsel Minor also suggested the Office of Risk Management help with the Safety Plans.

Director Gallo recommended Director Spearman write a letter to the Superintendent stating the Safety Committee is not approving the school site Safety Plans because the plans are incomplete and out of compliance.

Adrian Kirk, Director, Family & Community Office, reported the District is expanding Restorative Justice and this year has been a successful year.

Barbara McClung, Complimentary Learning, said the District was able to get funding to hire a Restorative Justice Program Manager.

Fonia Davis, Restorative Justice Oakland Youth, Castlemont Campus, said the District has a grant from the California Endowment - Building Healthy Initiatives, to have a Restorative Justice Program on the Castlemont campus. She said the money arrived late in the fall so the hiring process was not completed until January and the program got started in February. The Restorative Justice Program will train the adults first then the students. Twenty five teachers received the two day Intensive Peace Making Circle Training; there are sixty seven students in the introductory process; fifteen parents have been trained; and thirty five faith based leaders have been trained in the Restorative Justice process. Ms. Davis said Castlemont is beginning to utilize Restorative Justice Practices. She said there has been 15 Community Building Circles at Castlemont; eleven Circles with families in their homes; and there have been Conflict Circles as an alternative to suspending students. There is a juvenile justice component to Restorative Justice. Youth committing crime on campus or off campus will have the opportunity to go through a Restorative Diversion Process. Ms. Davis said this summer there will be intensive training for 6-8 weeks with 30

youth who will be a Peace Making Team on the Castlemont campus. A portable for Peace Making will be available in the fall where the youth can come.

Committee Member Comments

Director Gallo said he as attended several Restorative Justice Sessions. He said young people have the opportunity to work things out without going the suppression route. He said there is a fine line of what the law calls for and what the District is legally responsible for. He said at some schools some behavior the District can deal with and there is some behavior you have to say that it is not acceptable. He said sometimes we forget the difference between right and wrong and make excuses for certain behavior.

Chairperson Spearman said she appreciates the work of Restorative Justice and wants to see the work continue.

Mr. Kirk said another area of Restorative Justice is with the Juvenile Justice Center. The Chief of Probation is working with the District as the District constructs a re-entry plan for students returning from juvenile detention. There will be Multi-disciplinary Team Meetings held as quickly as possible when a student is returned from Juvenile Hall and before the student enters the classroom, if possible.

Changes in Family Engagement for 2011-12 School Year

Mr. Kirk said there will be more staff around engagement. He said he is submitting for Vistas for Volunteer and Mentor work so the District has additional low cost and high quality staff.
