SSC Federal Ed. Policy Requirements

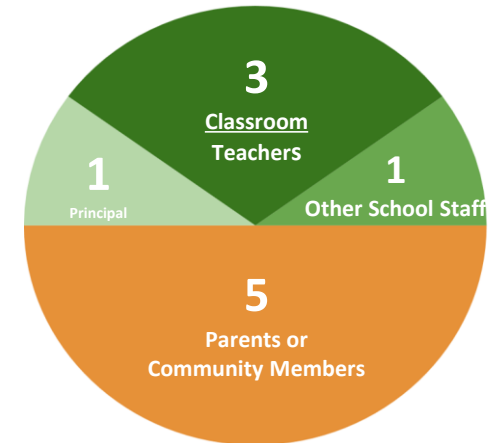
School Site Council Responsibilities:

- Developing, monitoring, and approving the School Plan Student Achievement - SPSA
- Key deliberative body for the allocation of Title I/IV funds to improve academic outcomes for students

Requirements for SSC Establishment:

- Peer Election of Members (Teachers, Other Staff, Parent/Community Members/Students) - composition requirements set by federal laws (see pie chart)
- SSC Training
- Approval of governing bylaws
- Election of SSC Officers

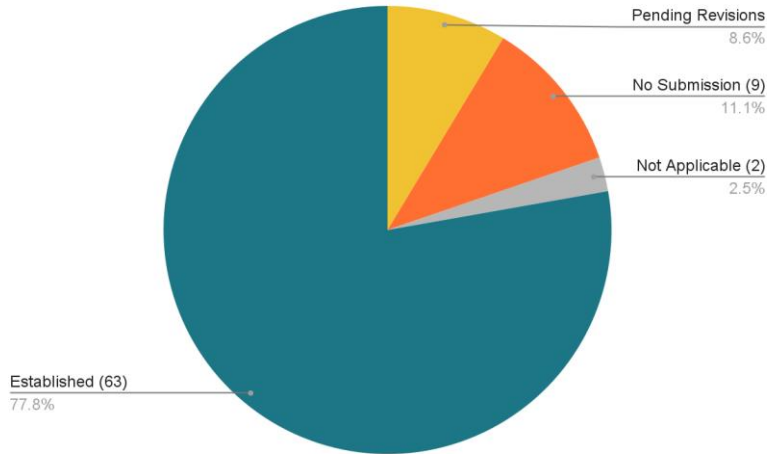
Sample composition

Established SSC = Meets Education Policy Requirements and SSC has authority to approve Title I/IV expenditures - (78% of OUSD SSCs are Established)

SELLS Ed. Policy Requirements

Representative body of parents of English learner students

Site English Language Learner Subcommittee Responsibilities:

- Act as advisory body to the Principal and staff in development of site plan for English Language Learners.
- Assist in the development of the schoolwide needs assessment
- Make parents aware of the importance of regular school attendance

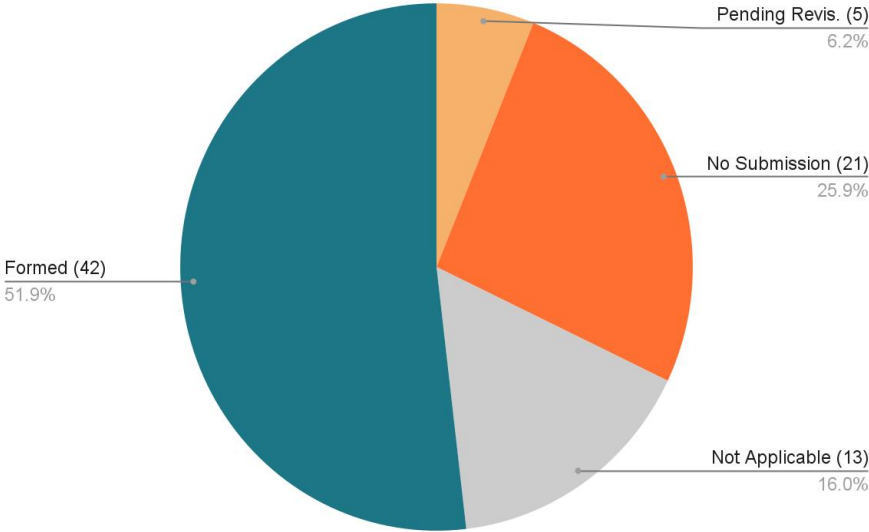
Primary Requirements for SELLS Formation:

- 3 Options: 1) stand-alone committee 2) designate to SSC OR 3) designate to subcommittee of the SSC
- EL Parent members must represent the percentage of EL students in the school's student body (3 member committee minimum)

SELLS Formation Progress Data

School Sites with 21 or more English Language Learners are required to form a SELLS (69 sites require SELLS, 52% are formed)
