What is the A-G Completion Improvement Plan?

A-G Completion Improvement Grant Program:

- AB 130 appropriates \$547.5 million for the A-G Completion Improvement Grant Program (Education Code Section 41590)
- AB 130 provides funding to LEA's to increase the number of students who graduate with A-G eligibility (particularly historically marginalized students)
- Funds will be apportioned based on the data used to calculate the Unduplicated Pupil Percentage (UPP) that LEA's certified as part of the 2020-21 Fall 1 submission.
- A-G completion rates determined from the 2020–21 four-year adjusted cohort graduation rate (ACGR) data.

OUSD's A-G Completion Improvement Plan

- High School Linked Learning develops a plan that fulfills the requirements set by the CDE and Alameda County Office of Education.
- The A-G Completion Improvement Plan must be discussed at a public and regularly scheduled meeting of the Board and then approved by April 1 (March 23).
- The A-G Completion Improvement strategies are funded at an amount to be finalized by the CDE across five years (2021-22 through 2025-26).
- Reporting to the Alameda County Office of Education is required twice: 12/31/23 and 8/31/26

Data and Context

What is A-G and why is it important?


- A-G courses (History, English, Math, Science, etc) must be passed with a C grade or higher to meet the UC / CSU requirements.
- Currently, too many graduates from OUSD do not meet the minimum eligibility for a UC / CSU because of having D or F grades on their transcript.

Key Investments

As a result of receiving these funds for unduplicated students to improve A-G eligibility, OUSD will increase and improve our services by:

- 1. Investing in professional development to increase the skill and capacity of new and existing staff;
- 1. Increasing staffing to allow more opportunities to expand credit recovery options;
- 1. Moving toward a mastery-based grading system and alternate methods for course completion;
- 1. Partnering with the Office of Equity, Family Engagement, and Community-Based Organizations to leverage relationships with students and communities to increase awareness of A-G and post-secondary planning.

With this A-G Completion Improvement plan, High School Linked Learning will deepen and expand our work, ensuring that unduplicated students have greater access to A-G courses approved by the University of California:

- Supporting school leaders and their teams to strategically develop plans that:
 - Track and monitor student support services and fill gaps;

- Ensure all students are served by a particular school counselor and/or college access partner;
- Create advising plan to ensure all students are properly counseled;
 - Transcript Audits
 - Course Selection
- Ensure that the courses in pathways and/or academies (introductory, concentrator, and capstone) are A-G approved in the UC CMP Portal and all courses are aligned to A-G requirements.
- Continued investment in our block scheduling strategy.
