2022-2023 Carryover Plan	N/A	N/A	<b>Professional Contracted Services:</b> <b>Funds to pay for transportation costs on the San Francisco Ferry and a field trip to the Exploratorium and Aquarium of the Bay.</b> At the Exploratorium, these funds will pay to immerse students in thought provoking, NGSS-aligned challenges which will show them what it is like to work in applying science and engineering. At the Aquarium of the Bay, students can apply their understanding of Ecology and Climate Change and how it affects local organisms in Biology. The field trip will help provide an opportunity for experiential, meaningful learning, which aligns with the goals of the Tiger family pathway and prepares students for future work in their 10-12 pathways. \$277.20 is the cost of Ferry tickets for 70 student passengers and 7 chaperones. The rate is \$1.80 per ticket.	\$269.50
