**WHEREAS**, the Child Development Center (CDC) and the campus located at 2025 40th Ave are still named Jefferson,

**WHEREAS**, the Board passed Board Policy 7310 to establish the process for renaming OUSD Facilities,

**NOW, THEREFORE, BE IT RESOLVED**, that the Superintendent of Schools, or designee, is directed to cause implementation of the BP 7310 procedures, process for the Board's consideration of a new name for the current Jefferson CDC and the entire campus at 2035 40<sup>th</sup> Avenue. .
