# LPS Oakland R&D Renewal Status

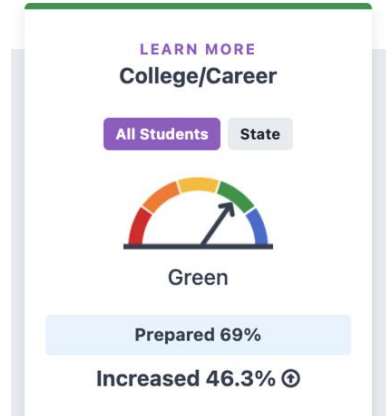
- ❑ **LPS Oakland R&D is classified in the "middle" category for renewal under EC Section 47607.2(b).** Based on the 2024 Dashboard, LPS Oakland R&D will remain in the Middle Performance Tier through the charter's expiration on June 30, 2025.
- ❑ **EC Section 47607.2(a) ("low" category) does not apply** because LPS Oakland R&D does not qualify for the "low" category based on the 2023 and 2024 Dashboards.
- ❑ **The 2023 and 2024 Dashboards inform** the renewal decision prior to June 30, 2025.



# LPS Oakland R&D: Significant Progress in College/Career Indicator (2024 )

College/Career Indicator Comparison (2024 CA Dashboard):

**Key Point:** LPS Oakland R&D outperforms state averages in key student groups, demonstrating strong progress in the College/Career Indicator, moving **LPS Oakland R&D to the Middle Performance Tier in Spring 2025.**



# Charter Renewal Denial Criteria (EC Section 47607.2(b)) – Middle Performing Charter School

A Board can only deny a middle-tier charter renewal based on factual findings that:

- **The charter school has failed to meet or make sufficient progress toward standards that benefit students.**
- **Closing the charter school is in the best interest of students.**
- **The renewal decision must prioritize academic performance over other factors.**

**Key Point:** LPS Oakland R&D **has made sufficient progress** and renewing the charter is **in the best interest of students.**



# ELPI Rate Comparison: LPS Oakland R&D vs. OUSD and Similar Schools

<b>ELPI (2024)</b>	28.2%	25.3%	2.9%	35.30%	-7.1%
<b>ELPI (2023)</b>	39.8%	36.4%	3.0%	32.50%	7.0%

**Key Point:** LPS Oakland R&D has outperformed OUSD averages for two consecutive years, achieving a higher overall ELPI rate of 39.8% in 2023 compared to similar schools. LPS Oakland R&D **has made sufficient progress with the ELPI.**



## LPS Oakland R&D Exceeds MAP Thresholds for 'One Year's Progress' (CGI $\geq$ -0.2)

**Key Point:** LPS Oakland R&D has shown sufficient progress in 'Reading' for most student subgroups, meeting MAP Conditional Growth Index (CGI) thresholds for 'One Year's Progress.'

## LPS Oakland R&D Exceeds MAP Thresholds for 'One Year's Progress' (CGI $\geq$ -0.2)

**Key Point:** LPS Oakland R&D has shown sufficient progress in Math, meeting MAP CGI thresholds for 'One Year's Progress' across most student subgroups in 2023 and 2024.



# Academic Performance: LPS Oakland R&D DFS Comparison with OUSD and Similar High Schools: CA Dashboard

**Key Point:** LPS Oakland R&D's DFS outperforms OUSD and similar high schools in ELA and Math, with the exception of Math in 2024. This measure highlights students' progress toward proficiency standards **and reinforces that renewing LPS Oakland R&D's charter is in the best interest of students.** As noted in the appendix, LPS Oakland R&D, in collaboration with other Leadership Public Schools, is dedicated to enhancing math instruction and accelerating growth in math achievement.



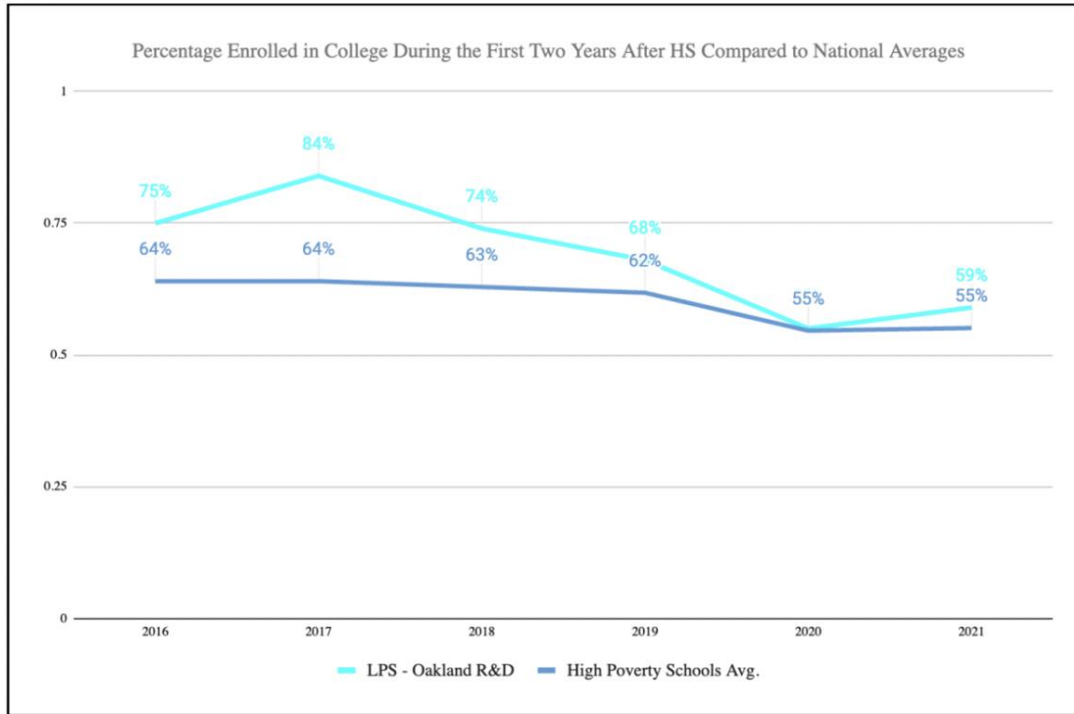
# College/Career Indicator (CCI): LPS Oakland R&D vs. OUSD and Similar High Schools

**Key Point:** LPS Oakland R&D demonstrates remarkable progress in the College/Career Indicator (CCI), achieving a 69% score in 2024—outperforming OUSD by 25.4% and similar high schools by 46.7%. This significant improvement from 2023 highlights the school's dedication to preparing students for post-secondary success, **affirming that an LPS Oakland R&D renewal is in the best interest of students.**



## (ii) Strong postsecondary outcomes, as defined by college enrollment, persistence, and completion rates equal to similar peers. (2nd Year)

**Key Point:** LPS Oakland R&D surpasses high-poverty school averages for post-secondary enrollment within the first two years after high school, highlighting its positive impact on student outcomes and **supporting its renewal as being in the best interest of students.**

## (ii) Strong postsecondary outcomes, as defined by college enrollment, persistence, and completion rates equal to similar peers.

### College Persistence

Figure 19 below shows the percent of students enrolled in college the first year after high school who returned for a second year, or freshmen to sophomore year persistence. According to this data, the analysis is below:

- *The freshman to sophomore year persistence for LPS Oakland's graduating class of 2021 was higher than their comparison OUSD District schools as well as the national high poverty schools average.*

**Key Point:** In 2021, LPS Oakland R&D outperformed both OCS comparison OUSD schools and the national average for high-poverty schools, **demonstrating its effectiveness and reinforcing that its renewal is in the best interest of students.**

## (ii) Strong postsecondary outcomes, as defined by college enrollment, persistence, and completion rates equal to similar peers.

### College Persistence

Figure 19 below shows the percent of students enrolled in college the first year after high school who returned for a second year, or freshmen to sophomore year persistence. According to this data, the analysis is below:

- *The freshman to sophomore year persistence for LPS Oakland's graduating class of 2021 was higher than their comparison OUSD District schools as well as the national high poverty schools average.*

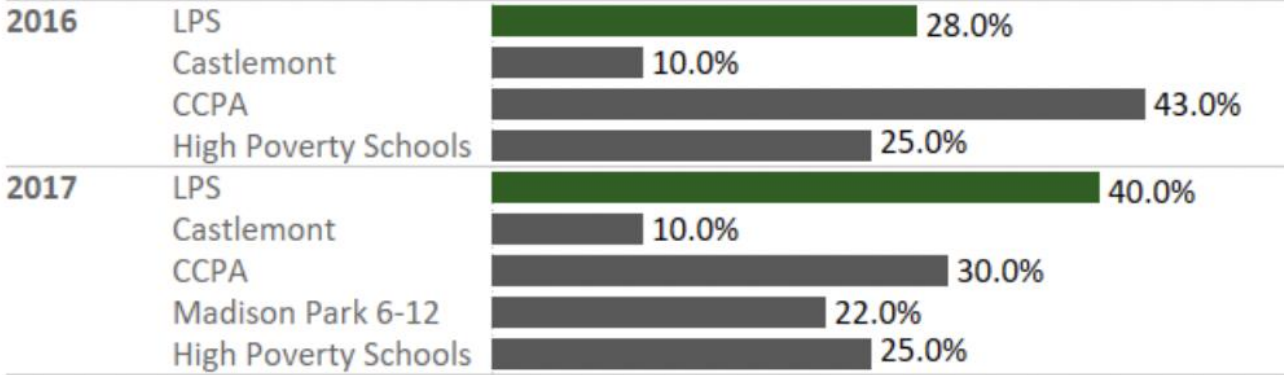

**Key Point:** When excluding grades 6-12 OUSD comparison schools, LPS Oakland R&D (grades 9-12) consistently outperforms the nearest school annually and exceeds the high-poverty school average in three out of six years. **This highlights that an LPS Oakland R&D renewal is in the best interest of students.**

**(ii) Strong postsecondary outcomes, as defined by college enrollment, persistence, and completion rates equal to similar peers.**

**Figure 20: Six Year Completion Rate, National Student Clearinghouse\***



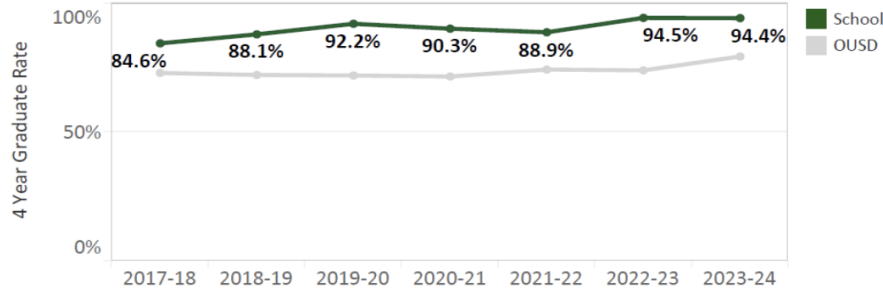

**Key Point:** LPS Oakland R&D outperformed high-poverty schools in six-year college completion rates, achieving 28% in 2016 and 40% in 2017. While CCPA surpassed LPS Oakland R&D in 2016, **LPS Oakland R&D led all other comparison schools, showcasing its commitment to post-secondary success.**



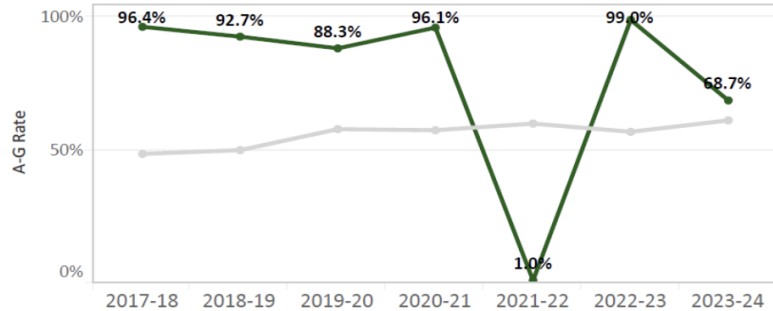
# LPS Oakland R&D: Strong Graduation and A-G Completion Rates

**Key Point:** LPS Oakland R&D consistently achieves higher graduation and A-G completion rates compared to schools with similar demographics. This performance underscores the school's commitment to student success, **supporting its charter renewal as being in the best interest of students.**

**Supporting Note:** Despite challenges such as staff turnover and underreporting in 2022 and 2024, LPS Oakland R&D demonstrated resilience, with actual A-G completion rates of 85% in 2021-22 and 94% in 2023-24.

# LPS Oakland R&D's Dual Enrollment Success

Grade Level	College Dual Enrollment 2023-2024
Grades 11 & 12	Over 75% of students successfully completed at least one college course.
Grade 12	Over 50% of students successfully completed two or three college courses.

**Key Point:** LPS Oakland R&D demonstrates strong student engagement and success in dual enrollment programs, with the majority of Grade 12 students earning college-level coursework credits. This achievement highlights the school's commitment to equipping students with advanced skills and opportunities for post-secondary success. **Renewing LPS Oakland R&D's charter is clearly in the best interest of students, ensuring continued access to high-quality, future-ready education.**

## **Key Points**

## Key Point:

- LPS Oakland R&D is implementing Illustrative Mathematics (IM) as part of a Leadership Public Schools initiative to improve math achievement.
- Teachers are collaborating with higher-performing LPS Hayward and Richmond teams.
- Educators are participating in yearlong professional development focused on IM's Universal Design for Learning.
- Teachers are receiving personalized coaching from a certified IM coach to enhance instructional practices.
